Under the GMA, counties can vote to expand their urban growth areas into farmland and natural habitat. Sometimes though, these UGA expansions are unnecessary and just contribute to excessive sprawl. In those cases, @Futurewise.WA might appeal the UGA expansion to the Growth Management Hearings Board (GMHB) and win a judgment that the UGA expansion was illegal under the GMA.

However, under the current framework, any permits issued for new construction in the expanded UGA are still valid *even if the UGA expansion is later ruled illegal.* SB 5042 would close that loophole. @Futurewise.Washington
