Washington lawmakers: Step up & fix our tax code!

Trump and his Congress are giving billions in tax cuts to the wealthy, while slashing billions from Medicaid, SNAP, and other critical services for working people.

Washingtonians are standing up and fighting back! We're calling on our leaders to save programs we rely on by asking the wealthy to pay more of what they truly owe.

TRUMP AND HIS CONGRESS ARE RIGGING THE SYSTEM TO HELP BILLIONAIRES – NOT THE REST OF US:

- By the skin of their teeth, Donald Trump and his followers in Congress managed to pass a budget bill that permanently slashes tax rates for big corporations and [gives the biggest tax handouts to billionaires and the top 1%](#), while giving table scraps, at best, to working families.
- Everyday Americans pay what we owe in taxes every single year. Our taxes pay for Medicaid, food assistance, Head Start, and all of the programs that we all depend on.
- Medicaid isn't fraudulent, food assistance isn't wasteful—it's what we all pay into. Gutting these lifelines in order to give more money to billionaires and big corporations, who don't pay what they owe in taxes, is the true fraud.

FEDERAL TAX CUTS WILL COST WASHINGTONIANS:

- Trump's Congress is giving away [\\$1.1 trillion to the rich in tax cuts](#) and they're paying for them by cutting health care and other services.
- Wealthy Washingtonians will receive [billions in tax cuts](#) every year under the Big Billionaire Bill.
- Collectively, the wealthiest 5% of Washingtonians (those making over \$447,400 annually) will get [over \\$7 billion in tax breaks](#). Over a period of three years, this is enough money to have more than covered our state's \$16 billion four-year budget shortfall that the legislature had to address this past session.
- Washington is set to lose about [\\$41 billion over 10 years in Medicaid funding](#).

- Up to [328,000 Washingtonians could lose coverage](#).
- Additionally, the state could lose hundreds of millions of dollars in SNAP funding and be forced to fill those gaps and [517,000 Washingtonians](#) would be at risk of losing food assistance.
- [Rural hospitals](#) and [grocery stores](#) are at risk of closing.
- Our state's elected leaders have a choice: Allow hundreds of thousands of Washingtonians to lose access to Medicaid, SNAP, and other vital services. Or tax the wealthy few who are getting even wealthier under this bill.

WE'RE COMING TOGETHER TO DEMAND THE MEGA-RICH PAY WHAT THEY OWE:

- We're standing up to say: enough is enough. It's time to ask the wealthiest in Washington to pay what they truly owe in taxes.
- Despite not paying their full share, the rich have amassed outsized power to shape our laws and keep the system rigged in their favor.
- We must rewrite the rules so the rich and big corporations finally pay their share—so that *our* tax dollars are invested in the things that help all of *us*—not just billionaires—thrive: health care, food, child care, schools, clean energy, and more.
