

Fellowship Terms and Conditions

These Terms and Conditions ("Agreement") govern the participation in the Asia Pacific School on Internet Governance (APSIG) ("hereinafter referred as the Event"). By registering and attending the Event, all participants, attendees, and users, hereinafter referred to as "Participants," agree to be bound by these Terms and Conditions.

1. Fellowship Package

- a. Accommodation:– The Asia Pacific School on Internet Governance (APSIG) will provide prepaid twin-shared accommodation with the same gender to all fellows. Fellows will be responsible for their own personal belongings and for keeping their shared spaces clean and tidy. If a fellow prefers to stay in a single room, (s)he shall be required to pay the full cost for the accommodation. Any additional stay outside of the aforementioned dates (before or after) shall be covered on own expense.
- b. Airfare:– APSIG will reimburse the cost of a round-trip economy-class air ticket for the most direct and economical route to and from the host location for all fellows. Fellows are responsible for any additional costs associated with their travel, such as baggage fees, seat upgrades, rescheduled flight, airport handling, missing flights etc.
- c. Stipend - APSIG may provide a fixed stipend to cover the visa fee, local transportation, extra meals and miscellaneous charges to the fellows, subject to the availability of funds.
- d. Travel Caveat: APSIG fellowship package is indicative and the fellow is responsible for any travel related information, e.g. Airport Rule, Transit Rule, Immigration rule, Custom rule, Aviation rule etc. APSIG, its committee members and affiliates are not liable for any damage due to lack of information on above issues.

2. **Assumption of Risk:** Participants acknowledge and agree that their participation in the APSIG workshop is voluntary and at their own risk. APSIG, its organizing committee, and its representatives shall not be held liable for any injuries, damages, losses, accidents, or incidents arising from or related to the Event, including but not limited to bodily harm, property damage, or financial loss.
3. **Content and Information:** APSIG provides educational content, materials, and discussions during the workshop. Participants understand that any information provided during the event is for general informational purposes only and should not be considered as professional advice. APSIG shall not be liable for any reliance placed on such information.
4. **Third-Party Content and Links:**– APSIG may include presentations, content, or references to third-party websites or resources during the workshop. Participants acknowledge that APSIG does not endorse or control the content of third-party sources and shall not be responsible for any damages or losses resulting from the use of such third-party content.
5. **Sponsorship Requirements:** Applicants abide by all the rules and regulations set out in these terms and conditions and shall provide all the required documents to the fellowship Committee, especially certain documents that are required by the Sponsor of the event for their accounting and reporting purpose. Non-acceptance of these conditions could result in the cancellation of the fellowship award.
6. **Data Protection:** APSIG does not collect and use the fellow's data for any purpose other than the purpose this was collected. APSIG may share the collected data/information to its sponsors as part of the reporting requirement.

7. **Event Changes or Cancellation:** APSIG reserves the rights to modify, reschedule, or cancel the event for any reason, including but not limited to unforeseen circumstances, technical issues, or insufficient registrations. In the event of cancellation, APSIG shall not be liable for any costs, damages, or losses incurred by Participants.
8. **Indemnification:** Participants agree to indemnify, defend, and hold harmless APSIG, its organizing committee, and its representatives from any claims, actions, liabilities, losses, damages, or expenses (including reasonable attorney fees) arising from or related to their participation in the Event or any violation of these Terms and Conditions.
9. **Force Majeure:-** APSIG shall not be liable for any failure or delay in performing its obligations under this Agreement caused by circumstances beyond its reasonable control, including but not limited to acts of nature, war, terrorism, government regulations, civil unrest, labour disputes, or equipment failures.
10. **Limitation of Liability:** To the maximum extent permitted by law, APSIG, its organizing committee, and its representatives shall not be liable for any direct, indirect, incidental, consequential, or special damages, including but not limited to lost profits, business interruption, or data loss, arising from or in connection with the Event, even if advised of the possibility of such damages. Any comment, remark, speech, data or presentation during the event by the participants and/or speakers will be deemed as their personal view(s).
11. **Governing Law and Jurisdiction:** This Agreement shall be governed by and construed in accordance with the laws of **Nepal**. Any disputes arising from or in connection with this Agreement shall be subject to the exclusive jurisdiction of the courts of **Nepal**.
12. **Severability:** If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

By registering and attending the APSIG workshop, participants acknowledge that they have read, understood, and agreed to these Terms and Conditions, and they voluntarily accept all risks associated with their participation.
