1. CONTEST DESCRIPTION

The 2026 Benefit + Awareness Month prize draw (the "Contest") begins on May 1, 2026 at 12:00 am Pacific Time and ends on June 1, 2026 at 11:59 pm Pacific Time (the "Promotion Period").

The sponsor of this Contest is the Opera Mariposa collective (the "Sponsor"). By participating in the Contest, each participant (the "Entrant") unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Sponsor, which shall be final and binding in all respects.

2. ELIGIBILITY

The Contest is open only to the following eligible participants:

Individual residents of, and physically located within, Canada (other than the province of Quebec); the United States; the United Kingdom; the European Union (excluding Italy); Australia; or another country that is NOT listed as a "Prohibited Jurisdiction" as follows: Afghanistan, Bahamas, Belgium, Belize, Bolivia, Cambodia, Chad, China, Colombia, Crimea, Cuba, Dominican Republic, Ecuador, Egypt, El Salvador, Ghana, Guatemala, Guinea, Haiti, Honduras, Iran, Iraq, Italy, Jamaica, Lebanon, Mali, Myanmar, Nicaragua, North Korea, Pakistan, Panama, Peru, Singapore, Somalia, Sudan, Syria, Tanzania (the United Republic of), Thailand, Trinidad and Tobago, Tunisia, Turkey, Uganda, Ukraine, Venezuela, Yemen, Zimbabwe, and any other country under sanction or embargo restrictions by Canada or the United States, or where local laws would prohibit the provision of or entry into this Contest; and who are 18 (except 19 in Alabama and Nebraska and 21 in Mississippi) years of age as of the date of entry, or of legal age of majority or older in their country of residence, whichever is higher.

Winners will need to correctly answer a mathematical skill-testing question as a condition of receiving a prize. All international, federal, provincial and local laws, rules, and regulations apply. Any participation by any ineligible person(s) is void. This contest is void where prohibited or restricted by law.

Representatives, members, delegates or affiliates of the Sponsor who have been designated to take responsibility for the operation of the Contest shall be ineligible to enter the Contest or to win any prize.

Individuals may enter this Contest multiple times.

4. HOW TO ENTER

There are several different ways to enter the Contest. Odds of winning depend upon the number of entries received. See below for all methods of entry; you can enter in more than one way if desired.

A. Make a campaign donation

B. Share on social media

Participate in the Blue Sunday social media event on Instagram, Facebook, or Bluesky by posting photos or graphics celebrating the Blue Sunday "tea party for ME" worldwide awareness-raising event, and by tagging both @operamariposa and #MariposaBlueSunday.

Posts or accounts must be set to "public" so that we can see them. Note that this giveaway is not affiliated with Instagram, Facebook, Meta, or Bluesky Social in any way. Social media accounts may be obtained for free. You can enter multiple times by this method.

C. Fill out the free entry form

To receive more free entries, manually fill out the entry form at <https://forms.gle/HqZ88sWzSUTswsjs9> to receive one (1) entry per form submission. Entrants may receive multiple entries via this method of entry.

Those who do not follow all of the instructions, fail to provide any required information, or fail to abide by these Official Rules or other instructions of the Sponsor may be disqualified at the Sponsor's discretion. All entries that are late, illegible, incomplete, misdirected, damaged, destroyed, forged, mechanically reproduced or otherwise not in compliance with the Official Rules may be disqualified at Sponsor's discretion.

In the event of a dispute as to the identity of any entrant, the entry will be deemed submitted by the account holder of the credit card on which payment was charged (if applicable) or by the account holder of the email address used to enter. "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet Access Provider, online service provider, or other organization (e.g., business, educational institute) that is responsible for assigning email addresses for the domain associated with the submitted email address. Winner(s) may be required to show proof of being the credit card holder or authorized account holder. If a dispute cannot be resolved to the Sponsor's satisfaction, the Potential Winner(s) will be disqualified.

5. WINNER SELECTION

The Sponsor or their designee will conduct a random drawing, and will award the prize(s), by June 8, 2026 to determine the Potential Winner(s) ("Potential Winners").

Entries are subject to verification by the Sponsor, and Potential Winners are not final Winners and will not receive a prize until their eligibility has been verified by the Sponsor.

Odds of winning depend upon the total number of eligible entries received. The Sponsor reserves the right in its sole discretion to disqualify all suspect entries.

6. WINNER NOTIFICATION AND VERIFICATION

Potential Winner(s) will be notified by email or by social media direct message (depending on their method of entry) within one week of being selected in a drawing by the Sponsor or their designee.

Potential Winners will not be declared Winners of any prize until their eligibility has been verified by answering a mathematical skill-testing question, and until they have signed any necessary documents at the request of the Sponsor, which may include an affidavit of eligibility and a liability release and/or a publicity release.

If a Potential Winner cannot be contacted within seven days after the Sponsor attempts notification, is ineligible to win a prize, fails to return any and all requested documentation within the time stated on the notification (whether or not Potential Winner actually receives that notification), declines the prize, or otherwise fails to comply with any aspect of these Official Rules, then the Potential Winner forfeits the prize in its entirety. - (c) electronic communications that are undeliverable, including but not limited to as a result of any form of active or passive filtering of any kind, or insufficient space in entrant's email account or computer; and
- (d) errors in the administration of this Contest.

The Sponsor reserves the right, at its sole discretion, to modify, cancel, terminate or suspend the Contest should any virus, bug, technical failures, unauthorized human intervention or other causes beyond Sponsor's control corrupt or affect the administration, security, fairness, integrity or proper conduct of the Contest. In the event of any such cancellation, termination or suspension, a notice will be posted and Sponsor in its sole discretion may select Potential Winners among all eligible, nonsuspect entries received prior to such time.

The Sponsor reserves the right, in their sole discretion, to disqualify entrants who tamper with the entry process or if their fraud or misconduct affects the integrity of the Contest or if they engage in

any inappropriate or unacceptable behavior in connection with the Contest. Released Parties reserve the right to correct clerical or typographical errors in promotional materials.

By participating in this Contest, all Entrants agree to release and hold harmless the Sponsor and all Released Parties from and against any claim or cause of action, including but not limited to, personal injury, death, damage to or loss of property, a privacy violation that may arise out of their participation in the Contest, or their receipt or use or misuse of any prize.
