


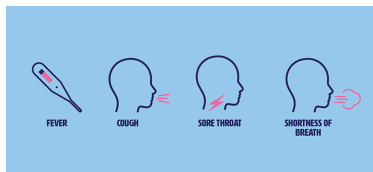

In-Person Learning

School will begin in-person on August 23rd for middle and high school students and on August 25th for elementary students. We will follow our Board approved district calendar for 2021-22.

	<p>ACADEMICS</p> <ul style="list-style-type: none">• Students will engage in all academic learning and activities based on the Colorado Academic Standards for their grade level.• Students will receive credit as normal for completion and accuracy of their work.• Students will be assessed with NWEA MAPs, DIBELS, and classroom assessments to help teachers determine learning gaps.• Students will be provided with academic support through intervention services as needed.• Students will primarily remain within their cohort grade level throughout the school day.• Families wishing to remain part of the Stratton School District, but needing to keep children home due to COVID-19 concerns will have a remote option available provided by the Stratton School District.
	<p>PHYSICAL DISTANCING</p> <ul style="list-style-type: none">• At all times, when possible, 3 feet of social distancing between all individuals will be established.• Elementary School: Remain with the class cohort as much as possible.• Secondary School: Increased space between used lockers• Maintain social distancing as much as possible for all-school gatherings.
	<p>FACE COVERINGS</p> <ul style="list-style-type: none">• Per CDPHE, face coverings are recommended/suggested.• Stratton School District will provide masks for any students and staff members who wish to wear a mask.• Face coverings will not be required for students and staff to attend school or teach in a classroom, unless a state mandate is issued that would require face coverings to be worn.



SYMPTOM CHECKS

- All students and staff members should be monitoring for symptoms of illness and remaining home if they have a fever.
- Other symptoms of illness could include: coughing, shortness of breath or difficulty breathing, chills, muscle aches, sore throat, new loss of taste or smell and exposure to someone with COVID-19 symptoms.
- Should a student or staff member begin to feel ill during the school day, they will be sent home.






HANDWASHING AND SANITIZING

- District staff will continue to educate students on the importance of handwashing to prevent the spread of viruses.
- Students will have dedicated time to wash their hands before eating and when returning inside from recess.
- Bathroom soap dispensers will be checked frequently and refilled as needed.
- Posters will be displayed in and around bathrooms and wash areas reminding students of the importance of handwashing.
- Hand sanitizer stations will be located in a variety of areas around each school and will be checked frequently and refilled as needed.
- Increased access to washing stations for middle and high school students will be implemented.
- Students and staff will be encouraged and reminded to wash hands regularly; use hand sanitizer; avoid touching eyes, nose, and mouth; and properly cover coughs and sneezes.



CLEANING AND DISINFECTING

- Increased circulation of outdoor air by opening windows and doors.
- Daily disinfection of touch points throughout all buildings.
- Twice daily disinfection of buses.
- Disinfectant supplies available in each room for staff to use, as necessary.
- Limit sharing of all student and staff supplies, utensils, devices, toys, learning aids, etc.

	<p>Transportation</p> <ul style="list-style-type: none"> • All students and drivers are required to wear face coverings while on a Stratton School District bus per federal mandate. • Students/athletes should sit one per seat on the school bus when feasible to establish social distancing.
	<p>Meals</p> <ul style="list-style-type: none"> • Students will eat all meals in the cafeteria following health and safety guidelines outlined above. (Hand washing or using hand sanitizer prior to entering the cafeteria and using safety protocols such as covering mouth when coughing or sneezing).
	<p>Recess</p> <ul style="list-style-type: none"> • Students will wash their hands or use hand sanitizer prior to going to recess and when returning from recess.
	<p>Passing Periods and Locker Use</p> <ul style="list-style-type: none"> • Students will not congregate in any area while transitioning to class. • When possible, students will be assigned a locker that is not directly next to another assigned locker. • Teachers will increase flexibility for students' use of the restroom to minimize the number of students in restrooms during passing periods.
	<p>Visitors</p> <ul style="list-style-type: none"> • Outside visitors to the school buildings must be in good health to volunteer in classrooms or when near our student body and staff. • BOCES and other providers will establish 3 ft. distancing between themselves and students during their sessions.
