

Privacy Policy for TradeVision AI Extension

This Privacy Policy describes how the TradeVision AI Chrome Extension ("the Extension") collects, uses, and shares information when you use our services.

****1. Information We Collect****

The TradeVision AI Extension is designed to provide AI-driven technical analysis of TradingView charts. To achieve this, the Extension collects and processes certain types of information:

*** **User-Provided Information:****

* ****OpenAI API Key:**** You are required to provide your own OpenAI API key to use the core AI analysis features of the Extension. This key is stored locally in your browser's synchronized storage (`chrome.storage.sync`) and is used solely to authenticate your requests to the OpenAI API. We do not have direct access to your API key on our servers.

* ****Custom Prompt and AI Model Selection:**** You can customize the AI prompt and select your preferred AI model. This information is stored locally in your browser's synchronized storage (`chrome.storage.sync`) to personalize your analysis experience.

*** **Automatically Collected Information:****

* ****TradingView Chart Screenshots:**** When you initiate an analysis, the Extension captures a screenshot of the visible portion of your active TradingView chart. This image data is sent directly to the OpenAI API for analysis. We do not store these screenshots on our servers.

* ****Analysis History:**** The Extension stores a history of your analyses, including the trading symbol, timeframe, and the AI-generated analysis text. This history is stored locally in your browser's synchronized storage (`chrome.storage.sync`) for your convenience.

* ****Tab Information:**** The Extension accesses information about your active tab (such as its URL) to determine if it is a TradingView chart and to enable context-specific features. We do not store your browsing history.

* ****User Activity:**** We collect information about your interactions with the Extension, such as when you trigger an analysis, open/close the analysis panel, or interact with context menu items. This data is used to facilitate the Extension's functionality and is not used to track your personal browsing habits.

****2. How We Use Your Information****

The information collected by the TradeVision AI Extension is used exclusively for the following purposes:

* ****To Provide Core Functionality:**** To enable the AI-driven technical analysis of TradingView charts by sending chart screenshots and prompts to the OpenAI API and displaying the results.

- * **To Personalize Your Experience:** To save your OpenAI API key, custom prompts, and preferred AI model for consistent use across your devices.
- * **To Maintain Analysis History:** To allow you to review past analyses directly within the Extension.
- * **To Improve User Experience:** To ensure the Extension operates correctly on TradingView pages and to provide relevant features.

****3. Information Sharing and Disclosure****

We do not sell, trade, or otherwise transfer your personally identifiable information to outside parties.

- * **OpenAI API:** The captured TradingView chart screenshots and your custom prompts are sent to the OpenAI API for processing. Your OpenAI API key is used for authentication with OpenAI. Please refer to OpenAI's Privacy Policy for information on how they handle data.
- * **No Third-Party Analytics:** We do not use third-party analytics services that collect personally identifiable information.
- * **Legal Requirements:** We may disclose your information if required to do so by law or in response to valid requests by public authorities (e.g., a court order or government agency).

****4. Data Storage and Security****

- * **Local Storage:** Most of your data (OpenAI API key, custom prompt, AI model, analysis history) is stored locally in your browser's synchronized storage (`chrome.storage.sync`). This means the data is stored on your device and synchronized across your logged-in Chrome browsers.
- * **Security Measures:** We implement reasonable security measures to protect the information under our control from unauthorized access, disclosure, alteration, or destruction. However, no method of transmission over the Internet or method of electronic storage is 100% secure.

****5. Your Choices and Controls****

- * **OpenAI API Key:** You can remove your OpenAI API key from the Extension's settings at any time. This will disable the AI analysis functionality until a new key is provided.
- * **Analysis History:** You can clear your analysis history from the Extension's settings.
- * **Extension Removal:** You can uninstall the TradeVision AI Extension at any time. Uninstalling the Extension will remove all locally stored data associated with it.

****6. Children's Privacy****

The TradeVision AI Extension is not intended for use by children under the age of 13. We do not knowingly collect personally identifiable information from children under 13. If we become aware

that we have collected personal information from a child under the age of 13, we will take steps to delete such information from our records.
