## **Privacy Policy**

We value your privacy very much and try our best to protect your personal information. This Policy explains you what information we collect about you, the purposes we use that information for, and who we share that information to. It also tells you your rights in relation to your privacy and how to contact us for more information or queries.

By accessing or using all or any portion of the Private Video Player Pro, you accept all the terms and conditions of this newest Policy.

Please read this Policy carefully because it describes how we may collect, use, process, manage and disclose your personal information.

We may update this Privacy Policy from time to time to reflect changes in our privacy practices or for other operational, legal or regulatory reasons.

If we make material changes to this Privacy Policy, we will give you notice of such changes by posting the revised policy on the App, and where appropriate, by other means. By continuing to use the App, after these changes are posted, you agree to the revised policy.

If you're under 14 years old(or the minimum legal age in your country to use the App), you must have your parent or legal guardian's permission to use our App. If a parent or guardian becomes aware that his or her child has provided us with information without their consent, he or she should promptly contact us and we take reasonable steps to ensure that such information is deleted from our files.

The types of personal information we collect include:

- (1)Contact information, such as email address.
- (2)Device information, such as: the type, brand, and language of handset device; mobile operating system; the type and operator of network; device identifiers (such as IDFA, IDFV). (3)Activity information, such as behavioral usage of the App.

We or our service providers may disclose your information without your permission (i) pursuant to judicial or other government subpoenas, warrants, or orders or otherwise to comply with law; (ii) where we believe an individual's rights, property, or safety or security is at risk; (iii) if we find that your actions violate our Terms of Use; or (iv) where otherwise required or permitted by applicable law.

We may use your personal information for the following purposes:

Fulfilling your service requests.

Contacting you with your consent; sending you information about products and services that may interest you; or sending you marketing information. If you do not want to receive these types of information, you can opt out at any time.

Sending you important notices, such as installation of and updates to operating system or application.

Improving the App and services through information analysis, and research.

Troubleshooting when you send us error reports.

Ensuring the security of App, services and users, executing and improving our loss prevention and anti-fraud programs.

Complying with and enforcing applicable legal requirements, industry standards and our policies.

In order to protect your information held with us and third parties we work with, we use industry-standard physical, procedural and electronic security measures, including encryption where deemed appropriate. We take reasonable measures to help protect your information from loss, theft, misuse and unauthorized access, disclosure, alteration and destruction.

We will retain your personal information for no longer than is necessary for the purposes stated in this Policy, unless otherwise extending the retention period is required or permitted by law. The standards we uses to determine the retention period are as follows: the time required to retain personal information to fulfill business purposes, including providing products and services; maintaining corresponding transaction and business records; controlling and improving the performance and quality of products and services; ensuring the security of systems, products, and services; handling possible user queries or complaints and locating problems; etc.

Depending on your location and subject to applicable law, you may have the following rights regarding the information we control about you:

The right to request that we rectify or update your information if it's inaccurate, incomplete, or outdated;

The right to request that we erase your information in certain circumstances as provided by law; The right to request that we export the information we hold about you to another company, provided it's technically feasible;

The right to withdraw your consent if your information is being processed based on your previous consent;

The right to object to the processing of your information if we are processing your information based on our legitimate interests; unless there are compelling legitimate grounds or the processing is necessary for legal reasons, we will cease processing your information upon receiving your objection; and

The right not to be discriminated against for exercising these rights.

To be able to offer our products and services for free, we serve third-party ads of advertising companies in the App. To enable the ad, we embed a software development kit ("SDK") provided by an advertising company into the product, which then collects information in order to personalize ads for you.
