

### **Known Information:**

Ehrendil joined the foundation fresh out of university with a PHD in Criminal psychology and law. Because of his legal background, he was brought on to assist in the development of Project "Lazarus", at Site-10, a site that was destroyed by a Sarkic cult. Since being transferred to Site-65 and being amnesticated with Class-E to ensure no recollection of the incident, he has risen up the ranks of the internal security department with the aim to ensure the foundation is protected from within, as much as the foundation aims to protect humanity from the very things it secures and contains.

## **History:**

Born in Warwick, Ehrendil's childhood was uneventful, mostly spent playing rugby and studying in school to ensure their enrollment into Oxford University. During his time at Oxford he studied criminal psychology and law in the hopes of becoming a lawyer. Upon leaving university he applied for a job with a law firm under the control of the foundation in London, England, where he worked for a few years. Upon being formally inducted into the foundation he was re-assigned to site-10 and assigned to a team working on Project "Lazarus" to assist with proving its legality should the UN ask questions. While the entity is believed to have connections to the Church of the Broken God, it would appear its presence alerted a Sarkic cult within the area who led an attack on the facility, leading to untold bloodshed. The survivors of that incident have been amnesticated of the incident and moved to other sites, Ehrendil has been moved to Site-65, in Saskatchewan, where he has been placed within the ISD department for closer observation.

### Site-65

Since joining Site-65 as an Operative of the Internal Security Department under Commissioner Dmitri 'Pixie' Yung where he was involved with a number of cases. While an operative and investigator he stuck to helping out Commissioner Yung with various tasks. Upon his promotion to Inspector, he quickly got to work assisting within the inter-departmental relations unit in order to improve ISD's reputation with other departments as well as work on projects to improve radio communication after the new shipment of analog radios arrived.

A survivor of the ISD wing massacre that saw 26 ISD personnel massacred by Alpha-1 operatives, he has worked tirelessly to improve relations with Alpha-1 stationed on Site-65 in order to prevent another such incident occurring. Following this event, the ISD department entered into a brief era of turmoil as it tried to rebuild after four separate Directors left the site and the department was left with no leadership. Ehrendil was granted the position of commissioner in order to ensure ISD had some semblance of leadership alongside his fellow inspector Rupert Mire, and newly arrived Silas Creed. As commissioner he continued his policy of improving relations as well as working with ethics to gain more powers for ISD as well as a full rework of the departmental policies.

Upon his ascension to Director, he promoted Inspectors Tim Drake and Dale to commissioners due to their wealth of knowledge in order to assist him in reworking ISD into a more efficient department. After his fellow Director was appointed, they have both been working towards a new goal for ISD in order to ensure that the department is capable of working with other departments while also granting basic rights to all staff with regards to legal representation during arrests.

Recently Ehrendil was involved with a case where a combat medic had been caught eating a human corpse and had hidden the half eaten remains in the medical fridges. Upon realization that the combat medic had been infected with a parasite and had been in contact with various personnel, as well as the parasite itself being stored in the medical fridges, mass testing was performed on those likely to be infected and four infected personnel were found. Ehrendil, being one of those individuals who was administered treatment despite his protest due to the parasite already starting to take control, slipped into a coma where medical doctors are currently overseeing his recovery and allowing his immune system and the cure time to fight off what remains of the parasitic infection. - Worked for Foundation controlled law firm "Branson & Sons" as a paralegal.
- Has worked out various agreements with other departments, contents unknown currently, except for the ISD/F3 agreement. Would be worth finding out the contents of those agreements.
- Recently entered a coma due to a severe parasitic infection caused by the actions of a combat medic.
- Has ordered the termination of various individuals outside his standard duties during
  multiple containment breaches, stated reason "To prevent a Keter level breach reaching
  the surface." Might be worth looking into the CCTV archives regarding these breaches to
  see if the orders were justified.
- Has a blatant disregard for his physical health, last incident led to him waiting 20 minutes to see the medical team after 682 bit off his arm below the elbow during a containment breach within the ECO lobby, only going once forced by an MTF operative and his constant smoking.
- Known to keep various vintage whiskeys and wines in his office, as well as a crate of cuban cigars, unclear how or where he is getting these items. Might be worth checking the shipment manifests for the past six months deliveries.
