Public Safety Update – Ofc Kevin Dilg

Dilg's [monthly](#) & [yearly](#) crime reports are linked in this sentence.

Dilg acknowledges Shotspotters do indeed detect gunshots, but usually the shooters a long gone by time the police actually arrive.

Discussion about what kind of offense unlawful gunfire is, can actually just be a city ordinance violence when not intentionally fired at a person or occupied building. City can't make its own gun laws. Concerns voiced about anticipated state law changes (Stand Your Ground, etc) which may just *worsen* the city's gun violence.

LaSalle Park had a 57% increase in part 1 crimes 2021 → 2022, a larger % than all other neighborhoods in District 3. The vast majority of these crimes occurred in LaSalle Park Apartments, generally between residents or people who know each other. Crime against strangers is not itself as high.

Dilg acknowledges the police can't resolve the crime problem on their own. The department is only reactive in nature.

Constructive things residents can do to help discourage violence:

- Build simple relationships with LaSalle Park Apts residents if opportunity provides. Say hello! Hire people for odd jobs like shoveling snow.
- Be visible and establish your presence! Go for a leisurely walk around the neighborhood, pick up litter, trim overgrowth in the medians or by fences.

City housing authority is working to identify and evict residents responsible for violence, but this process takes time. Sal Martinez is also board member with the authority, so he's very much in the middle of things working very hard to stop cycles of violence.

We also have brand new SLMPD Chief Robert Tracy.

Good Development Group Intro – Greg Gleicher CEO

Large new development project on the riverfront just south of downtown, bordering LaSalle Park. Large portion of the 1st phase will include manufacturing, expecting to bring many jobs. 1st stage: 1 million square ft, rehab of existing structures, take 2 – 2 ½ years. Hoping to bring tenants that rely heavily on prefab construction for facilities. Location in center of country ideally makes the location ideal for shipping.

GDG also working to get incentives it qualifies for, brownfield tax credits, historic tax credits.

GDG wants to recall St. Louis' heritage as an innovation hub.

Residential and commercial space would come as later phases.

Very first stage: stabilize existing structures, e.g. Crunden-Martin building and adjacent, construction for industrial tenants.

GDG gladly encourages community support, letters of endorsement.

GDG is in communication with the Hungarian Catholic church congregation, the church isn't going anywhere.
