**Play Park Rules and Policies**

All park rules and policies are designed with one purpose in mind - providing dogs a safe and fun place to play with their humans. Rules are outlined below and are subject to being updated as needed.

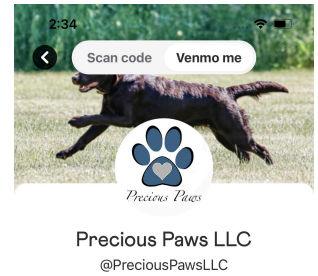
1. All dogs must remain on leash until inside the fenced area and the gate is secured in the closed position.
2. Please close and latch the gate as you leave - this helps keep the chickens, cats, etc out of the Play Park. Should any of these be in the Play Park when you arrive, provide them time to escape the area prior to releasing your dog.
3. You must pick up all dog feces in waste bags. You are welcome to throw the bag away in the waste can outside of the Play Park. (There are no bathroom facilities for humans so plan ahead!)
4. Your dog(s) must have the following vaccinations and proof must be shared prior to use of the Play Park:
  - o Current rabies vaccination
  - o Distemper, Adenovirus, Parvovirus, Parainfluenza within 3 years
5. Your dog is asked to be up to date on flea/tick preventative as well as internal parasite preventative (de-wormer).
6. It is recommended that you discuss with your veterinarian the following vaccinations due to the Play Park being located in a rural setting and frequented by dogs:
  - o Lyme disease
  - o Leptospirosis
  - o Bordetella
7. Please be respectful of the property and recognize you are only authorized to use the Play Park. Please do not wander the woods, yard, pond, or any other areas of the private residence.
8. Children must be closely supervised by parents and must remain in the Play Park. Children and adults should not climb on the equipment as it is intended for dog use only. Remind any children they should not interact with the animals that share our property - including but not limited to the cats, chickens, and pheasants.
9. Dogs must not be left unattended in the Play Park.
10. Please do not allow your dogs to dig holes in the Play Park.
11. Please report any areas of concern (equipment that is broken, fencing in need of repair, etc) so we can give these areas our attention.
12. Recognize this is a rural area and the play park may have mounds and/or holes due to moles, gophers, etc. Please play carefully!
13. You are welcome to move the agility equipment if desired, but please do so carefully.
14. There is a water hydrant at the corner of the shed by the Play Park. Feel free to use it to give your dog a drink (for hygiene reasons, please bring your own bowl)
15. The Play Park is under video surveillance; your activities may be recorded.
16. Treat the park with the same respect you would treat your own home.
17. Violation of these rules may result in your suspension of use of the Play Park.

**Current rates:**

\$5 per dog, per 45 minute session

We ask that you limit yourself to 4 dogs at a time. If you have more than 4 dogs that you would like to attend during your scheduled visit, please reach out to us. You can Venmo @PreciousPawsLLC or use the drop box for cash.

Small groups can contact Precious Paws for pricing but the park is limited to 10 dogs at one time from any small group.

**Park Hours:**

10am-8pm (will vary in fall due to sunset times)

**Park Operational Dates:**

Play Park will be closed throughout winter - likely closing before Thanksgiving and re-opening in April (weather dependant)

**Prior to first Play Park session you must submit:**

- Copy of current vaccination record showing current rabies and DAPP within the last 3 years.
  - You can either email these to [trainpreciouspaws@gmail.com](mailto:trainpreciouspaws@gmail.com) or “regular” mail them to 1743 Dakota Ave, Waverly IA 50677 at least a week prior to your first visit. You can also upload them through the online liability waiver.

**Available equipment:**

Please keep your dogs abilities in mind and use the equipment within their own limits.

Equipment may vary but can include several pieces of homemade and purchased items such as:

A frame  
Teetor Totter  
Dog Walk  
Pause table  
Jumps  
Weave poles (6)  
Kiddy pool (you will need to fill and empty when done - we have a hose and hydrant available)  
Chuck-It balls
