PART 3: Purim—Battlefield Ethics and Jewish Law

Tuesday, March 8, 2022 at 7 PM via Zoom

Presenter: **Rabbi Michael Broyde**, Professor of Law, Emory University School of Law

Is war a time and space in which there is no law, or a place in which there is 'law of war'? This question is both important and widely discussed in the Jewish tradition from the Talmud to the present. Not surprising, this question has been reexamined repeatedly since the establishment of the State of Israel. In this talk, we examine this thousand-year-old discussion and share many diverse -- and somewhat competing -- Jewish views of battlefield ethics and war law.
