This is especially helpful if you know someone who has been charged DUI vs DWI Minnesota. Lawyers who specialize in other areas, like estate planning or personal injury, can refer you to an excellent Minnesota criminal defense lawyer.

Your Criminal Defense Attorney should know the basic elements of criminal laws and their statutory penalties. Clear Costs or Fee Structure

In a flat fee structure, you are billed one flat rate rather than hourly. Flat fees are helpful in cases that are more routine. Lawyers also bill by the hour. MN Criminal lawyers often request a retainer when they bill hourly. A retainer acts as a deposit and the lawyer will work against the amount you paid up front. For example, if a lawyer bills at \$200 an hour, a \$2,000 retainer would get you up to 10 hours of attorney time. Although you may think that choosing the cheapest lawyer makes sense, it's unwise to make your decision based on fees alone. The lawyer's expertise matters greatly, especially if you are facing DUI vs DWI Minnesota.

One factor to consider when looking for the best MN criminal defense attorney for your case is the lawyer's enthusiasm. A good criminal lawyer isn't just knowledgeable and experienced: her or she should also enjoy their work.
