## Awards 2023-24

# The following awards winners are first nominated by Kappa Psi Brothers and then are selected by the Northwest Province Awards Committee.

- Nomination forms will close Friday, February 16th at 8 PM PST
- Each Brother can submit a max of (1) nomination per award
- Each nominee is eligible to win only one individual award
- For individual awards, the nomination should be submitted by somebody other than the nominee.
- For chapter awards, any individual may submit a nomination on behalf of their chapter.
- You are not required to answer the award prompts listed under each award, but these can be helpful talking points if you are unsure how to start your nomination

## **Chapter Regent of the Year (Nomination Form)**

The purpose of this award is to recognize the exemplary leadership of a chapter regent who served during the 2023-24 year and demonstrates exceptional leadership skills, the ability to inspire and motivate others, unwavering character, and a commitment to upholding the high ideals of the fraternity. This regent exemplifies the mission and values of Kappa Psi and has made a significant impact on their peers.

#### Eligibility:

- Must be in good standing with Kappa Psi
- Must be a Brother in the Northwest Province
- Must have held a regent position during the 2023-24 term
- Collegiate and Graduate Brothers are eligible

#### **Award Prompts:**

- 1. How has this chapter regent supported individual members of the chapter and executive board?
- 2. Under this regent's leadership, how has this organization excelled over the past year?
- 3. Why do you believe the nominee has created a legacy that positively impacts their chapter, council, and beyond?

## **Outstanding Graduating Brother of the Year (Nomination Form)**

The purpose of this award is to recognize Brothers in the last year of their program who have consistently and positively contributed to the chapter experience throughout their time as a Collegiate Brother.

## Eligibility:

• Must be in good standing with Kappa Psi

- Must be in their final year of the pharmacy program they are enrolled in
  - Anticipated to graduate in 2024
- Must be a Collegiate Brother

#### Award Prompts:

- 1. How has this Brother gone above and beyond the expected responsibilities of a member in their last year of pharmacy school?
- 2. Describe how this Brother has made a significant impact within and outside of the chapter.

## **Emerging Leader of the Year (Nomination Form)**

The purpose of this award is to recognize Collegiate Brothers that are the leaders of tomorrow. This person has not yet reached their last year in their respective pharmacy program, but their track-record reflects a strong potential to excel in future leadership opportunities. This is an individual who is dependable and has shown significant, positive growth in their leadership skills and consistent implementation of their leadership talents.

## Eligibility:

- Must be in good standing with Kappa Psi
- Limited to Brothers who are not currently completing the last year of the pharmacy program they are enrolled in
  - P1s and P2s are eligible
  - P3s are eligible for 4-year programs
- Must be a Collegiate Brother

#### **Award Prompts:**

- 1. Describe the nominee's involvement in the chapter.
- 2. Describe the nominee's involvement in other organizations and in the community.

## **New Member of the Year (Nomination Form)**

The purpose of this award is to recognize outstanding achievements by chapter new members in their first year of membership.

## Eligibility:

- Must be a Collegiate Brother that was initiated into the chapter between Feb. 2023 Jan. 2024
- Must be in good standing with the Chapter, the Northwest Province, and Central Office

#### Award Prompts:

- How has this nominee become involved within the chapter since becoming a Brother?
- How has this member pursued leadership and fellowship outside of the chapter since joining?

## 4 Pillars (Nomination Form)

The purpose of this award is to recognize a Brother of the Northwest Province that exhibits Industry, Sobriety, Fellowship, and High Ideals in every action that they do.

### Eligibility:

- Must be a member of the Northwest Province
- *Must be in good standing with the fraternity*
- Collegiate and Graduate Brothers are eligible for this award
- Members of the Northwest Province Executive Committee are not eligible for this award

#### **Award Prompts:**

- Provide examples of how this nominee exhibits the 4 Pillars of Kappa Psi in everything that they do.
- How does this nominee encourage others to exhibit the 4 Pillars of Kappa Psi?
- Describe the positive impact this individual has on their peers and the chapter.

## **Graduate-Collegiate Collaboration (Nomination Form)**

The purpose of this award is to celebrate and promote positive relationships between Collegiate and Graduate Brothers of Kappa Psi within the Northwest Province.

#### Eligibility:

- Any collaborative event that is inclusive of both Collegiate and Graduate Brothers of the Northwest Province
- Event must not violate risk management policies

## Nomination Requirements:

- Description of Event (date, activity, etc.)
- Chapters involved in the event
- Number of Collegiate and Graduate Brothers in attendance
- Photos of event

# The following award winners are determined by the Northwest Province Executive Committee

#### **Professionalism**

The purpose of this award is to recognize the Collegiate Chapter who exhibits professionalism through attendance and meeting deadlines.

#### Eligibility:

- Northwest Province Collegiate chapters only
- Chapter must be in good standing with the Province and Central Office
- Delegate(s) must be present for roll call at Winter Province Assembly

#### Winner Selection:

The winner will be selected based on the number of deadlines met (taxes, delegate/proxy forms, dues, roster updates, etc.), attendance (%) at chapter meetings, and attendance (%) at Winter Province Assembly. The winning chapter must be in good standing with the Northwest Province and The Central Office, and the Chapter Delegate(s) must be present for roll call at the start of the Business Meeting on Saturday, February 17th.

#### One for All and All for One

The purpose of this award is to recognize the chapter that has participated in the most Northwest Province philanthropic challenges since the previous Winter Province Assembly.

#### Eligibility:

• All Northwest Province Chapters are eligible for this award

#### Winner Selection:

Determined by chapter participation in monthly philanthropy challenges.

#### **Farthest Traveled Brother**

The purpose of this award is to recognize the Brother who traveled the farthest to attend Winter Province Assembly.

## Eligibility:

- Must have registered for Winter Province Assembly
- Must have checked-in for Winter Province Assembly prior to the start of the Business Meeting on Saturday, February 17th

#### Winner Selection:

The distance traveled will be calculated using <u>www.distancefromto.net</u> to create a straight line between cities (in miles). The cities used in this calculation will be Vancouver, BC, Canada and the "home city" of the Brother's chapter. The Brother must check-in for the assembly prior to the start of the Business Meeting on Saturday, February 17th and must be present at the Banquet to receive the award.

## **Farthest Traveled Chapter**

The purpose of this award is to recognize the Northwest Province Chapter with exceptional representation at the Province Assembly. This will be awarded to the chapter whose members have the farthest combined distance traveled to attend the Winter Province Assembly.

## Eligibility:

- All Northwest Province chapters are eligible
- Brothers must be present for roll call at the start of the Business Meeting on Saturday, February 17th

#### Winner Selection:

The total distance traveled will be calculated using <u>www.distancefromto.net</u> to create a straight line between cities (in miles). The cities used in this calculation will be Vancouver, BC, Canada and the "home city" of the visiting chapter. This distance will be multiplied by the number of Brothers present for roll call at the start of the Business Meeting. The winning chapter's Delegate(s)/Representative(s) must be present to receive the Award at the Banquet on Saturday, February 17th.

## **Early Bird**

The purpose of this award is to recognize the first Brother to register for the Winter Province Assembly.

### Eligibility:

- Must be registered for Winter Province Assembly
- Must check-in for the assembly prior to the start of the Business Meeting on Saturday, February 17th

#### **Late Bird**

The purpose of this award is to recognize the Brother who waits until the last possible minute to register for the Winter Province Assembly.

#### Eligibility:

- Must be registered for Winter Province Assembly
- Must check-in for the assembly prior to the start of the Business Meeting on Saturday, February 17th

## **Best Chapter Report**

The purpose of this award is to recognize the Collegiate Chapter with the best Chapter Report, which is voted upon by the Kappa Psi chapters in the Northwest Province. The report should summarize a series of exceptional activities/achievements that have taken place since the previous Winter Province Assembly.

#### Eligibility:

- Northwest Province Collegiate Chapter
- Chapter must be in good standing with the Northwest Province and The Central Office
- *Delegate(s)* are required to be present

#### Winner Selection:
