ACAMAID Partner Toolkit

A recently-proposed DEA rule change would prevent doctors from prescribing controlled substances via telemedicine without first conducting an in-person evaluation. Terminally ill patients nearing the end of their lives are almost always too sick to visit a doctor in person. This rule change would restrict access to health care, and make it incredibly difficult for terminally ill patients to receive routine palliative care and medicines that can ease their pain. We must act quickly to generate as much public comment as we can, to convince the DEA to consider the harmful impact of this rule change on terminally ill Americans.

Subject Line: We must protect terminally ill patients

The DEA recently proposed a rule change that would prevent doctors from prescribing controlled substances via telemedicine unless they have conducted an in-person evaluation.

This would significantly harm terminally ill patients by restricting access to routine end of life care and medicines that can ease pain.

We must prevent this rule from taking effect as written. Submit a public comment to protect terminally ill patients now. And hurry — the public comment period is only open until March 31.

Terminally ill patients are often far too sick at the end of their lives to visit a doctor in person. But that is the only way they'd be able to access medication that eases pain and suffering if this new rule takes effect.

It may not be the intent of the rule change — but it is an unintended consequence, and the rule should not be implemented as currently written.

It only takes a few minutes to submit a letter to protect terminally ill patients. We've added suggestions and a sample letter you can use to make it even easier.

The Deadline for public comments is March 31st. Please submit a public comment right away to prevent a newly-proposed DEA rule from harming terminally ill patients!
