

TERMS OF USE (USERS OF PNEUMACARE platform)

INTRODUCTION

All visits and use of the “**PneumaCare**” platform is governed by these Terms of Use. This document (referred to as our “Terms of Use”) gives you information about the terms upon which we agree to provide, permit and allow you access and use of the Website.

Dealings, transactions and provider engagements on the Platform shall be in strict compliance with the policies, regulations, codes of conduct and ethics as applicable to providers, professionals, and service vendors respectively.

Users are required to acquaint themselves with these policies, regulations, codes of conduct and ethics.

Changes, alterations and subsequent amendments of this Terms of Use shall be updated and available to users on the PneumaCare platform.

Users shall be solely responsible for regular checks and familiarization with such changes, alterations and amendments to the Terms of Use and shall be bound by such changes upon subsequent use of the Systems and Services. Where Users disagree with any subsequent changes, alterations and amendments of this terms of use, such Users shall indicate their refusal in writing through a notice submitted to PneumaCare Limited.

Definitions

‘Affiliate’ means an entity that, directly or indirectly, controls, is under the control of, or is under the common control of PneumaCare Limited.

patents, copyrights, trademarks, service marks, intellectual property and/or other that accrue to such content.

‘Data Protection
Regulations’

means the Nigeria Data Protection Regulation 2019

‘Platform’

means the website designed and created for facilitating consultations and access to healthcare products and services between prospective clients and users and an aggregation of third-party medical services, health care providers and other related health service vendors.

‘Provider’

means any third-party medical professionals, health care providers and other related health service vendors onboarded on the PneumaCare platform.

‘Products and Services’

means the aggregation of services and healthcare products offered by Providers and available to users on the Platform at any given time.

“Terms”

means this Terms of Use and any other Data Privacy Policy that may be applicable to the use of or access to this Platform

‘User’

means any individual who uses the Platform including any authorized representative of a corporate entity.

Terms of Use

These Terms and Conditions constitute a legally binding agreement made between you, whether personally or on behalf of an entity (“you” or “user”) and ***PneumaCare*** a company registered under the laws of Nigeria and having its registered address at **50 Ebitu Ukiwe Street, Jabi, Abuja** (“PneumaCare”, “we,” “us” or “our”), concerning your access to and use of the PneumaHealth online platform as well as any other media form, media channel, or related, linked, or otherwise connected thereto (collectively, the “e-platform”).

PneumaCare Limited, as the owner and operator of the PneumaCare platform, shall reserve the right to revise these Terms and Conditions at any time, and/or issue supplemental terms and conditions at its sole discretion, with or without notice, by posting an updated version to the Platform. All Users agree that it shall be an obligation to periodically visit and review the most current Terms and Conditions. User Warranties and Representations.

- (i) That you are of legal age (18 years) to enter into a binding contract.

- (iii) That the platform will not be used for medical emergencies and would not replace the existing medical emergency services.
- (iv) That you will maintain the accuracy of such information and promptly update such registration information as necessary.

- (vi) That your use of the Platform will not violate any applicable law or regulation.
- (vii) That you would be willing to use the Platform in accordance with the terms and conditions contained herein.

Service Marketplace

You may be required to register using their email addresses and a strong password on the PneumaCare platform by clicking the visiting patients.pneuma.care. For a user who has been onboarded on the platform, you will be able to authorized the PneumaCare platform to access your medical records from a primary source.

You are required to keep your password confidential and will be solely responsible for all use of your account and password.

PneumaCare reserves the right to remove, reclaim, or change a username you select if it determines, in its sole discretion, that such username is inappropriate, obscene, or otherwise objectionable.

Limitation of Liability & Indemnity

PneumaCare reserves the right to modify and make changes to these terms at any time and any continued use of the Platform will indicate the acceptance of any adjustment to these terms.
