Continuous Improvement Plan – Des Hertz was present to share a presentation. Academic Achievement Goal – STAR Math and Reading assessments. Tracking growth

Academic Achievement Goal – STAR Math and Reading assessments. Tracking growth throughout the year. Safe and Healthy Students Goal – This goal looks at attendance and behavior. Tracking student attendance and major behaviors happening at the schools. Question on reporting of major behaviors – minor behaviors are also being addressed and written up, but the tracking focuses on the majors. Discussion on the attendance and what are the factors behind the absences.

Honorable Mention – Tracey Witherspoon was highlighted. She shared her time periods at Twinfield School. She has been hired by Twinfield School 3 times. She enjoys her time at Twinfield School and always feels supported.

C28 – transgender and non-conforming students. Some points discussed:

Matt gave an update on feedback from VSBA.

Discussion on if staff and community are included in this policy. Adding community could be problematic.

It was noted that with Vermont laws and regulations, protection is granted to all.

Open discussion on Vermont laws vs Federal laws.

Michelle – would like Twinfield to state in the language just Vermont law.

The board would like Matt to take to the attorney the possibility of removing the Federal language.

Michelle disagrees that adding community to the policy is problematic.

Board will look at Policy B5 & A22 to see if their language carries the protections.

Matt discussed with the board that depending on if Federal law changes, schools cannot break the laws without risk of losing funding.

Discussion on existing policies and starting the review of all the policies starting with the oldest first.

VSBA Update – Janna Osman

Logged into a VSBA meeting. Janna discussed what was being discussed in legislature. With the structure that the State is looking at 50% of staff would lose their jobs.
