

The WPT Home Game™ “Pimp My Home Game” Promotion
OFFICIAL RULES

NO PURCHASE NECESSARY FOR ENTRY.

**VOID IN WASHINGTON STATE AND WHERE OTHERWISE PROHIBITED OR
RESTRICTED BY LAW.**

1. **PROMOTION DESCRIPTION:** The WPT Home Game™ “Pimp My Home Game” Promotion (the “**Promotion**”) is a user-generated content contest that begins on or about **September 1, 2026 at 12:00:00 a.m. pacific time (“PT”)** and ends **September 22, 2026 at 11:59:59 p.m. PT** (the “**Promotion Period**”). Entries for the Promotion will be accepted only during the Promotion Period, and eligible entrants will have the opportunity to enter to win the Prize (as defined below). Sponsor’s computer is the official time-keeping device for the Promotion. Entries submitted before or after the Promotion Period will not be eligible.

During the Promotion Period, each eligible individual that enters the Promotion (herein, referred to as an “**Entrant**”) will submit a video depicting the Entrant’s existing home poker game setup, together with the story behind that game, for consideration by a panel of judges appointed by Sponsor (the “**Judges**”). Following the close of the Promotion Period, the Judges will select one (1) grand-prize winner (the “**Prize Winner**”) to receive a full home poker room makeover, as set forth more fully below.

Entry in the Promotion does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Promotion, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Grand Cru Concepts, Ltd., Arch. Makariou III & Evagorou, 1-7, MITSU 3, 1st floor, Flat/Office 102, 1065, Nicosia, Cyprus (“**Sponsor**”) and the Judges, which shall be final and binding in all respects and in all matters relating to the Promotion. These Official Rules are in addition to, and shall be read together with, the General Terms & Conditions applicable to WPT Home Game and ClubWPT™ Gold; in the event of a direct conflict between these Official Rules and such General Terms & Conditions with respect to the Promotion, these Official Rules shall control.

2. **ELIGIBILITY:** The Promotion is open only to individuals who, at the time of entry: (i) are legal residents of one of the fifty (50) United States or the District of Columbia, **excluding residents of Washington State** and excluding residents of any state, territory, or other jurisdiction that is identified as an “Excluded Territory” in the applicable ClubWPT Gold Terms & Conditions (available at <https://www.clubwptgold.com/>), or in which the Promotion is otherwise prohibited or restricted by law; (ii) are at least eighteen (18) years of age and the age of majority in their jurisdiction of primary residence; (iii) are the host of a recurring home poker game and have the authority to permit Sponsor to

access, modify, and film the premises at which that game is played; and (iv) may legally enter and win the Promotion according to the laws of their present location. Individuals are responsible for knowing and complying with all eligibility requirements and all such laws.

Officers, directors, official ambassadors, contractors, agents and employees of Sponsor, Bellota Labs, WPT Enterprises, Inc., ClubWPT, and each of their respective parents, subsidiaries, licensors, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies, prize suppliers, and any other entity involved in the development, production, or administration of the Promotion (all such individuals and entities referred to collectively, the “**Promotion Entities**”), and each of their immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they live) and/or people living in the same household of each (whether or not related) are NOT eligible to enter the Promotion or win a prize. Void where prohibited.

If a social media platform is used to conduct or promote the Promotion, please note that this Promotion is in no way sponsored, endorsed or administered by, or associated with, any social media platform. Eligibility to enter and/or claim a Prize may be restricted by Sponsor for legal and/or regulatory compliance.

3. HOW TO ENTER: During the Promotion Period, eligible individuals may enter the Promotion by completing **both** of the following steps (each completed entry, a “**Submission**”):

1. **Create your entry.** Record a video of your existing home poker game setup, not more than ninety (90) seconds in length, that shows: (a) the room and playing table; (b) any snacks, drinks, chips, cards, or accessories used; (c) the players who regularly attend; and (d) the story behind the game, including how long you have played, your house rules, memorable moments, and why your setup needs a makeover.
2. **Submit your entry.** There are two entry methods: (1) Visit the official Promotion landing page and complete the entry form in full, including your full name, date of birth, email address, telephone number, mailing address (used to verify eligibility and, if selected, to arrange the Prize), and a link to the video you created in Step 1 (uploaded to a public or unlisted URL on YouTube, Vimeo, Google Drive, or a similar service that is freely accessible to Sponsor for the duration of the Promotion and for six (6) months thereafter), or (2) Reply or quote tweet to an unrelated third party a WPT Pimp my Home Game post on Twitter, and, the reply needs to mention the city and state (only) where you are located.

Limit: one (1) Submission per person and per household for the duration of the Promotion Period. Duplicate, incomplete, illegible, mechanically reproduced, or automated entries will be disqualified. Submissions become the property of Sponsor and will not be acknowledged or returned. Normal internet access, mobile data, and message charges from your carrier or provider may apply and are the sole responsibility of the Entrant. No purchase, payment, subscription, or in-app purchase of any kind is necessary to enter or win.

Any Submission that is considered by Sponsor in its sole and absolute discretion to be obscene, libelous, hate speech or otherwise objectionable, in whole or in part, will be disqualified and will not be eligible for entry. Proof of submission is not considered proof of delivery to or receipt of such entry. Furthermore, Sponsor shall have no liability for any Submission that is lost, late, misdirected, garbled, intercepted, undeliverable, or not received by Sponsor for any reason, or for any technical malfunctions of any kind.

If entering the Promotion involves social media, please note that Entrants are providing information to Sponsor and not to any social media platform(s). Entry must be made by the Entrant, only through the designated method(s) specified above. Entries made by any other individual or any entity, and/or originating at any other web site or e-mail address, including but not limited to commercial sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Promotion. Tampering with the entry process or the operation of the Promotion, including but not limited to the use of any device to automate the entry process or the use of multiple accounts to enter the Promotion, is prohibited and any entries deemed by Sponsor, in its sole discretion, to have been submitted in this manner will be void. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry(ies) will be deemed ineligible. Sponsor shall not be responsible for incorrect or inaccurate entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Promotion or by any technical or human error which may occur in the processing of the entries in the Promotion. Sponsor assumes no responsibility or liability for any error, omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of, entries.

4. SUBMISSION CONTENT REQUIREMENTS: Each Submission must:

- Be the original work of the Entrant, who must own or control all rights necessary to submit it and to grant the rights granted in Section 12 below;
- Feature only individuals who are of legal age in their jurisdiction and who have given the Entrant permission to appear, be filmed, and be featured in a promotional contest and in Sponsor's advertising and promotional materials;
- Not depict or promote any illegal activity, and not depict any real-money wagering conducted in violation of applicable law;
- Not contain any third-party music, footage, artwork, logos, trademarks, or other content for which the Entrant has not secured all necessary rights;
- Not contain any material that is unlawful, obscene, defamatory, threatening, harassing, sexually explicit, hateful, discriminatory, or otherwise inappropriate; and
- Not disparage Sponsor, the Promotion Entities, or any other person or entity.

Sponsor reserves the right to disqualify any Submission that, in its sole discretion, fails to meet these requirements or otherwise does not comply with these Official Rules, with or

without notice to the Entrant. Sponsor is under no obligation to review, monitor, use, or publish any Submission.

5. JUDGING AND WINNER SELECTION: Following the close of the Promotion Period, the Judges will review all eligible Submissions and select one (1) grand-prize winner based on the following criteria:

- **Makeover Potential (33%)** — how much the Entrant’s current setup would benefit from a full home poker room makeover;
- **Storytelling and Personality (33%)** — the strength of the group’s story, characters, and the reason the game matters; and
- **Overall Creativity (34%)** — originality, humor, and entertainment value of the Submission.

In the event of a tie, the tied Submission receiving the highest score in Makeover Potential will be selected. Sponsor may, in its sole discretion, publicly announce a group of three (3) to five (5) finalists prior to announcing the Prize Winner; finalist selection confers no prize and no right to any prize. All judging determinations are final and binding in all respects.

The potential Prize Winner will be notified by email and/or telephone using the contact details provided at entry, on or about **September 28, 2026**. The potential Prize Winner must respond to the first notification attempt within **five (5) business days** of the date of first notification to claim the Prize; otherwise the Prize may be forfeited in its entirety and an alternate winner may be selected from among the remaining eligible Submissions. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. Time is of the essence in awarding the Prize. If any potential Prize Winner is found to be ineligible, has not complied with these Official Rules, or declines the Prize for any reason prior to award, or if the Prize or a Prize notification is returned as unclaimed or undeliverable, such potential Prize Winner will be disqualified and an alternate winner may be selected.

Odds of winning depend on the number and quality of eligible Submissions received during the Promotion Period.

6. PRIZE/ODDS: One (1) Prize will be awarded in the Promotion, as follows:

Grand Prize (one): A full home poker room makeover, coordinated and delivered by Sponsor at a single residential location within the continental United States mutually agreed by Sponsor and the Prize Winner (the “**Makeover**”). The Makeover may include, as determined by Sponsor in its sole discretion, items such as a WPT-branded poker table and felt, dealer chairs, a chip set, cards, lighting, LED wall signage, wall décor, and installation labor. Total approximate retail value (“**ARV**”): **Twenty Thousand U.S. Dollars (\$20,000 USD)**.

Prize location. The Makeover will be delivered only at a residential location within the continental United States. If the Prize Winner is a resident of Alaska or Hawaii, or is

otherwise unable to provide a mutually agreeable location within the continental United States at which the Makeover may be installed and filmed, Sponsor reserves the right, in its sole discretion, to (i) coordinate delivery of the Makeover components to an alternate location, or (ii) award a substitute prize of comparable value, which shall constitute full satisfaction of Sponsor's prize obligation, and no other or additional compensation will be awarded.

Prize restrictions. The Prize is awarded "as is" with no warranty or guarantee, either express or implied. The Prize is non-assignable and non-transferable. No cash alternative, transfer, or substitution of the Prize is permitted, except that Sponsor reserves the right in its sole discretion to substitute a prize (or any component thereof) of equal or greater value if the advertised Prize or any component becomes unavailable, in whole or in part, for any reason. All details, specifications, quantities, brands, and other restrictions of the Prize not specified in these Official Rules will be determined by Sponsor in its sole discretion. Any prizes pictured in point-of-sale, online, television and print advertising, promotional packaging, and other Promotion materials are for illustrative purposes only.

Costs not included. The Prize does not include, and the Prize Winner is solely responsible for: any structural, electrical, plumbing, or other modification to the premises not expressly agreed by Sponsor in writing; any permits, homeowner association or landlord approvals, or insurance; the removal or disposal of existing furnishings other than as Sponsor elects to remove; ongoing maintenance, repair, warranty, or replacement of any Makeover component after installation; and travel, accommodations, meals, ground transportation, and any other incidental expenses of the Prize Winner or any guest.

Taxes. All federal, state, and local taxes, and the reporting consequences thereof, and any other fees or costs associated with the Prize and not expressly specified herein, are the sole responsibility of the Prize Winner. The Prize Winner will be issued an IRS Form 1099 reflecting the ARV of the Prize if required by law.

Nothing herein requires Sponsor to hold any activity or event. Nothing set forth herein shall be construed to require Sponsor to hold any activity, filming, installation, or event described in the Prize description (each a "**Prize Event**") at any particular time, or at all. In the event that a Prize Event does not or cannot take place as scheduled or at all, for reasons including but not limited to scheduling conflicts, cancellations, postponement, supply or contractor unavailability, an event of Force Majeure (as defined below), or for any other reason, then in lieu of such Prize Event the Prize Winner will receive a substitute prize of comparable value, which shall constitute full satisfaction of Sponsor's prize obligation to the Prize Winner, and no other or additional compensation will be awarded.

Limit one (1) prize per person and per household. **Odds of winning depend on the number and quality of eligible Submissions received during the Promotion Period.**

7. **PRIZE CLAIM; REQUIRED DOCUMENTS:** Acceptance of the Prize is conditioned on the potential Prize Winner, and, where applicable, each person appearing in the Submission or in any Makeover content and each owner, landlord, or lawful occupant of

the premises at which the Makeover is to be installed, executing and returning to Sponsor, within the time period required by Sponsor (and in any event within five (5) business days of Sponsor's request unless otherwise stated), each of the following as applicable: an Affidavit of Eligibility, a Liability Release, (where imposing such condition is legal) a Publicity Release, a Filming and Location Release, a Property Access and Installation Consent, a Minor's Parental Consent (if any person appearing is a minor), a Travel Release, and any required tax documentation, in each case in the form provided by Sponsor (collectively, the "**Prize Claim Documents**").

Failure or refusal to sign and return all Prize Claim Documents within the time required, failure to pass any verification or identity check conducted by Sponsor, or any failure to comply with these Official Rules may result in disqualification, forfeiture of the Prize, and selection of an alternate winner. Sponsor reserves the right to verify the eligibility of any Entrant and the authenticity and originality of any Submission at any time.

8. **THE MAKEOVER; ACCESS, FILMING AND CONDUCT:** The Prize Winner acknowledges and agrees that the Makeover will be documented and filmed by or on behalf of Sponsor for use in longer-form and short-form content, including a "before" walkthrough, a build sequence, a reveal, and subsequent gameplay on the WPT Home Game app. As a condition of accepting the Prize, the Prize Winner agrees to:

- Grant Sponsor and its crew, contractors, and invitees reasonable access to the premises on the dates and during the hours designated by Sponsor for the purpose of designing, delivering, installing, and filming the Makeover;
- Obtain, at the Prize Winner's sole cost, any consent, approval, or permission required from any co-owner, spouse, landlord, homeowner association, or other party having an interest in the premises, and provide written evidence of the same to Sponsor upon request;
- Cause each individual who will appear in or be recorded as part of the Makeover content to execute Sponsor's Publicity Release and Filming Release prior to filming; and
- Cooperate reasonably and in good faith with Sponsor's production schedule, including participating in interviews, the reveal, and a home game played using the WPT Home Game app.

Sponsor makes no representation as to the date, duration, scope, or specific contents of the Makeover, each of which is subject to change in Sponsor's sole discretion. In the event the Prize Winner engages in behavior that, as determined by Sponsor in its sole discretion, is obnoxious or threatening, illegal, or that is intended to annoy, abuse, threaten or harass any other person, Sponsor reserves the right to terminate the Makeover, any related travel, and any other applicable experience early, in whole or in part, and to remove the Prize Winner and/or any companion from any venue, with no further compensation and without any obligation to complete or restore the premises.

9. **PUBLICITY RELEASE:** By participating in the Promotion, in addition to any other grants which may be granted in any other agreement entered into between Sponsor and

any Entrant in and/or winner and/or participant of the Promotion, each Entrant irrevocably grants the Promotion Entities and their respective successors, assigns and licensees, the right to use such Entrant's name, photograph, likeness, voice, statements, biographical information, WPT Home Game username, and any other personal characteristics, in any and all media for any purpose, including without limitation, advertising and Promotion purposes as well as in, on or in connection with the WPT Home Game or ClubWPT™ Gold program, any World Poker Tour program or event, the Promotion or other promotions, and each Entrant and/or prize winner(s) and/or participant(s) hereby releases the Promotion Entities from any liability with respect thereto, except where prohibited by law.

10. **GENERAL PRIZE CONDITIONS:** Prizes are non-assignable and non-transferable. All details and restrictions of the prizes not specified in these Official Rules will be determined by Sponsor in its sole discretion. No cash alternative or substitution of prizes will be allowed, except Sponsor reserves the right in its sole discretion to substitute prizes of comparable value if any prize is unavailable, in whole or in part, for any reason. Prizes will be awarded only if the potential prize winner fully complies with these Official Rules. Any prizes pictured in point-of-sale, online, television and print advertising, promotional packaging, and other Promotion materials are for illustrative purposes only. The Prize Winner shall be solely responsible for all federal, state, local and/or other taxes, and the reporting consequences thereof, and for any other fees or costs associated with the applicable prize. Each potential prize winner and his or her guest may be required to execute the Prize Claim Documents in order to claim the Prize. If any potential winner fails or refuses to sign and return all Prize Claim Documents within the time period specified by Sponsor, the winner may be disqualified and an alternate winner may be selected.
11. **REPRESENTATIONS AND WARRANTIES/INDEMNIFICATION:** Each person who enters this Promotion represents and warrants as follows: (i) the Submission is wholly original with the Entrant, and as of the date of submission, is not the subject of any actual or threatened litigation or claim; (ii) the Submission does not and will not violate or infringe upon the intellectual property rights, rights of privacy or publicity, or other rights of any other person or entity; (iii) the Entrant has obtained the written consent of every individual appearing in the Submission (and, if any such individual is a minor, of that individual's parent or legal guardian) to the Submission and to the uses contemplated by these Official Rules; (iv) the Entrant has the authority to permit Sponsor to access, modify, and film the premises depicted in the Submission; and (v) the Submission does not and will not violate any applicable laws, and is not and will not be defamatory or libelous.

Each Entrant hereby agrees to indemnify and hold the Promotion Entities harmless from and against any and all third party claims, actions or proceedings of any kind and from any and all damages, liabilities, costs and expenses relating to or arising out of any breach or alleged breach of any of the warranties, representations or agreements of the Entrant hereunder. Sponsor makes no warranties, and hereby disclaims any and all warranties, express or implied, concerning any prize furnished in connection with the Promotion. WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, SUCH

PRIZES ARE PROVIDED “AS IS” WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, AND SPONSOR HEREBY DISCLAIMS ALL SUCH WARRANTIES, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND/OR NON-INFRINGEMENT.

12. **GRANT OF RIGHTS:** For good and valuable consideration, the receipt and legal sufficiency of which is hereby acknowledged, by submitting a Submission each Entrant hereby irrevocably grants Sponsor and its affiliates, licensees, successors, and assigns a perpetual, worldwide, royalty-free, irrevocable, sublicensable, and transferable right and license to use, reproduce, edit, modify, adapt, composite, morph, scan, duplicate, alter, publish, distribute, stream, publicly display, publicly perform, exploit, and create derivative works from the Submission (in whole or in part) and the Entrant’s name, likeness, voice, biographical information, and WPT Home Game username, throughout the universe, in perpetuity, by means of any and all media and devices now known or hereafter devised, for any purpose, including advertising, promotion, and commercial use, without further notice, review, approval, compensation, or consideration, except where prohibited by law.

Entrants waive any right to inspect or approve any such use and irrevocably waive all so-called moral rights in the Submission to the fullest extent permitted by law. Sponsor shall have the right, in its sole discretion, to edit the Submission for any purpose which Sponsor deems necessary or desirable, and shall have the right to freely assign its rights hereunder, in whole or in part, to any person or entity. Sponsor shall retain the rights granted in each Submission even if the Submission is disqualified. Sponsor is under no obligation to use any Submission. Where Sponsor elects to feature a Submission in the “Home Game Hall of Fame” clip series or in any other Promotion content, Sponsor may, but is not required to, obtain a separate signed release from the applicable Entrant.

13. **PRIVACY:** Except as otherwise contemplated in these Official Rules, and to the extent Entrants may otherwise elect at the time of entry, personal information collected in connection with the Promotion will be used in accordance with Sponsor’s privacy policy located at <https://www.clubwptgold.com/>. Information collected at entry may be used to verify eligibility and identity, to administer the Promotion, to contact the potential Prize Winner, and to arrange and deliver the Prize.
14. **GENERAL LIABILITY RELEASE/FORCE MAJEURE:** Entrants agree that the Promotion Entities and, if applicable, the social media platform(s) (A) shall not be responsible or liable for, and are hereby released from, any and all costs, injuries, losses or damages of any kind, including, without limitation, death, bodily injury, and damage to real or personal property, due in whole or in part, directly or indirectly, to participation in the Promotion or any Promotion-related activity, to the design, delivery, installation, use, or removal of the Makeover or any component thereof, or from Entrants’ acceptance, receipt, possession and/or use or misuse of any prize, and (B) have not made any warranty, representation or guarantee express or implied, in fact or in law, with respect to any prize, including, without limitation, to such prize’s quality, workmanship, or fitness for a particular purpose. Sponsor assumes no responsibility for any damage to an Entrant’s, or any other person’s, computer system, phone, or other electronic device used

to participate in the Promotion, or for any computer system, phone line, hardware, software or program malfunctions, or other errors, failures, delayed computer transmissions or network connections that are human or technical in nature. Without limiting the generality of the foregoing, Sponsor is not responsible for incomplete, illegible, misdirected, misprinted, late, lost, damaged, stolen, or postage-due prize notifications; or for lost, interrupted, inaccessible or unavailable networks, servers, satellites, Internet service providers, websites, or other connections; or for miscommunications, failed, jumbled, scrambled, delayed, or misdirected computer, telephone or cable transmissions; or for any technical malfunctions, failures, difficulties or other errors of any kind or nature; or for the incorrect or inaccurate capture of information, or the failure to capture any information.

Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Promotion, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Promotion, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. No mechanically reproduced, illegible, incomplete, forged, software-generated or other automated multiple entries will be accepted.

Sponsor reserves the right to modify, extend, suspend, or terminate the Promotion if it determines, in its sole discretion, that the Promotion is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other causes beyond Sponsor's control have destroyed or severely undermined or to any degree impaired the integrity, administration, security, proper play and/or feasibility of the Promotion as contemplated herein. In the event an insufficient number of eligible entries are received and/or Sponsor is prevented from awarding prizes or continuing with the Promotion as contemplated herein by any event beyond its control, including but not limited to fire, flood, natural or man-made epidemic of health or other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, supply chain disruption, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal, state or local government law, order, or regulation, public health crisis, order of any court or jurisdiction, or other cause not reasonably within Sponsor's control (each a "**Force Majeure**" event or occurrence), then subject to any governmental approval which may be required, Sponsor shall have the right to modify, suspend, extend or terminate the Promotion.

These Official Rules cannot be modified or amended in any way except in a written document issued in accordance with law by a duly authorized representative of Sponsor. The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.

Each person who enters this Promotion agrees that: (i) they are participating in the Promotion and in any travel or filming activity associated with the Promotion voluntarily

and without any duress or undue influence, and recognize, acknowledge and accept that there are certain risks of physical injury and property damage associated with travel, construction, installation, and filming activity, and voluntarily agree, as a condition of participating in the Promotion, to assume the full risk of any physical or psychological injuries, costs, damages or losses, regardless of severity, that they may suffer as a result of participating in such Promotion. If a person participating in the Promotion is injured in the course of participating in the Promotion, that person's participation in the Promotion shall be considered consent to receive medical assistance and/or treatment from medical personnel at their expense, and the Promotion Entities will not obtain insurance on a participant's behalf. NOT ALL HAZARDS AND DANGERS CAN BE FORESEEN. IT IS IMPOSSIBLE FOR THE PROMOTION ENTITIES OR ANYONE ELSE TO GUARANTEE ABSOLUTE SAFETY. 15. **GOVERNING LAW/JURISDICTION:** ALL ISSUES AND QUESTIONS CONCERNING THE CONSTRUCTION, VALIDITY, INTERPRETATION AND ENFORCEABILITY OF THESE OFFICIAL RULES OR THE RIGHTS AND OBLIGATIONS OF ENTRANTS OR SPONSOR IN CONNECTION WITH THE PROMOTION SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE INTERNAL LAWS OF THE STATE OF DELAWARE WITHOUT GIVING EFFECT TO ANY CHOICE OF LAW OR CONFLICT OF LAW RULES OR PROVISIONS THAT WOULD CAUSE THE APPLICATION OF ANY OTHER STATE'S LAWS.
16. **ARBITRATION PROVISION:** By participating in this Promotion, each Entrant agrees:
(i) that any and all disputes the Entrant may have with, or claims the Entrant may have against, the Promotion Entities relating to, arising out of or connected in any way with (a)
