

Terms and Conditions for the Study and Dine Initiative

Initiative: Study and Dine – Distinction Points Redemption for Meals

1. Introduction

By participating in the **Study and Dine initiative** through the **Distinction platform**, you (the student) agree to the following terms and conditions set by **FlexiSAF Edusoft Ltd.** ("FlexiSAF"). This initiative allows you to redeem meals at participating food vendors by using your earned **Distinction points**.

2. Eligibility

- The initiative is available to all **students registered on the Distinction platform** who meet the following criteria:
 - You must have a **minimum of 1000 points** in your **Distinction account** to qualify for meal redemption.
 - Only paying subscribers are eligible to participate in this initiative.

- Students must present their **Distinction ID** when claiming their meal at the participating food vendors.

3. Accumulation of Points

- **Earning Points:** Points are earned based on your activities on the **Distinction platform**, including participating in quizzes, completing study tasks, and other academic engagement activities.
 - **Point System:** For every **1000 points**, you are entitled to **1 meal** at participating food vendors only.
 - Points can be **redeemed** for a meal only if you have accumulated the necessary points. For example, **2000 points** equals **2 meals**. Points are non-transferable and can only be used for meals under the **Study and Dine initiative**.

4. Redemption Process

- **Eligible Meal Redemption:** If you qualify for a meal (e.g., you have accumulated at least 1000 points), you can claim your meal at participating food vendors.
 - **Claiming Meals:** You can claim your meal **the day after you qualify**, as meals will only be available for redemption the **next day** to allow for verification by food vendors.
 - You must **present your Distinction ID** to verify your eligibility for the meal.

5. Participating Food Vendors

- **Food Vendor Eligibility:** Meals will only be available at **approved food vendors** partnered with FlexiSAF. The list of participating vendors will be shared on the **Distinction platform**.
 - **Meal Availability:** The availability of meals is subject to the **vendor's stock** and operational hours. Meals are offered on a **first-come, first-served** basis.

6. Redemption Restrictions

- Meals can only be redeemed for personal use and cannot be transferred to another person.
 - **Meals cannot be redeemed immediately upon qualification**—they must be claimed the following day.
 - **Point verification:** FlexiSAF may suspend or deny meal redemption if discrepancies in point balances or fraudulent activity are detected.

 - Vendors will receive **daily updates** of eligible students and will be required to **verify the student's Distinction ID** before providing the meal.

- FlexiSAF will also ensure that payment to vendors is processed promptly for meals claimed by eligible students.

- FlexiSAF reserves the right to **modify** or **terminate** the Study and Dine initiative at any time without prior notice.
 - In case of **system errors** or **discrepancies in point calculation**, FlexiSAF will investigate and may make adjustments to ensure fairness in the redemption process.

- FlexiSAF will collect and store **student data** (such as Distinction ID and point balances) to verify eligibility for meal redemption.
