Privacy Policy

1. COLLECTION OF INFORMATION

This personal information may encompass data falling within the ambit of 'personal information' as defined by relevant data protection laws applicable in India. Personal data, or personal information, means any information about an individual from which that person can be identified. It does not include data where the individual identity has been removed.

- 1.2. **Log Standard Data**: standard data provided by your browser upon using our Services. Such information may include but is not limited to browser type and version, Internet Protocol (IP) address, geolocation data, username, and email.
- 1.3. **Third-Party Provided Data:** Other information about you that is publicly available or provided to us by third parties may be combined with automatically collected information solely for the purpose of engagement of our services.
- 1.4. **Profile and Usage Data**: includes information about your usage of our website and your current job role, interests, preferences, job application data, feedback and survey responses.
- 1.5. **Financial details**: includes information retention of Bank account number, contractual service fee details etc.
- 1.6. **Professional Information**: includes CV/ resume, referrals or other provided documents for engagement of our services.
- 1.7. **Analytics:** We may use a variety of online analytics products that use cookies to help us analyze how users use our Services and enhance your experience when you use the Services.

2. USE OF INFORMATION

- 2.1. Use of the collected information may be for the following purposes -
