# Broward County Volleyball Officials Association Inc. 2025-2026 Registration & General Information

#### **GENERAL INFORMATION:**

The Broward County Volleyball Officials Association Inc. (BCVOA) membership registration will commence on July 7, 2025. Registration and payment will be processed electronically through our website only.

All individuals should familiarize themselves with the Association's governance prior to registering with the Association. The governance can be found on Association website @ https://www.bcvoa.org.

#### **REGISTRATION:**

All members must register with both the Florida High School Athletics Association (FHSAA), and the Broward County Volleyball Officials Association Inc. (BCVOA). It is recommended that both FHSAA and BCVOA Inc. registration is done in succession.

07/16/2025 - 07/30/2025 - \$75.00

07/31/2025 - 08/04/2025 - \$100.00

Student Officials – No fee (A student official is defined as being 17-18 years of age and currently enrolled in high school.) A student officials should contact the Association President, Troy Bailey (504) 491-2384, or <a href="mailto:tbailey@teamkeylite.net">tbailey@teamkeylite.net</a> prior to registering. A special promo code will be provided to eligible student officials to waive the Association registration fee.

The eligibility registration deadline is August 04, 2025.

Returning members before starting your registration please have your current security badge and vendor number available. Those items are mandatory fields for returning officials. Any member security badge that has expired must obtain a current security clearance under the Jessica Lunsford Act (FL HB1887). Anyone that has misplaced or lost their badge, you must obtain a replacement badge. It is strongly recommended that members don't delay in getting their security clearance. No member will be allowed to officiate any level of basketball with the Student Athletics & Activities (SAA), MSAA and BCVOA Inc.

Student officials are exempted from obtaining a JLA. In addition, any law enforcement officer holding an active commission can apply for a waiver. A waiver can be sought through the SAA office by contacting Dawn Turner @ (754) 321-1202 or dawn.turner@browardschools.com

All security clearance and badge replacement must be conducted through Field Print. Below is a link to Field Print registration and Codes. Information can also be found on the website (look for the fingerprint). All members must provide the Association with a copy of their current security badge. Again, no member shall be allowed to work any games assignments until the JLA requirements are met. **NO EXCEPTION**

Security badges will be sent to the SAA office after it have been processed by Field Print and School Board Police Dept. Dawn will process accordingly and mail to your address supplied on the application. So please ensure that you are properly registered.

Note: The registration process is only completed when the application is completed in its entirety. Fees are paid, and a current security badge has been provided

  - o W-9 Form (if you currently have a vendor number from another sport a W9 is not required)
  - o ACH Request Form (only needed if you DO NOT have a vendor number)
  - o Security Badge (current) (Student officials are not required to obtain a security clearance. Student official must contact Association President @ (504) 491-2384 prior to registering.

### Transfer Official Member:

- FHSAA Registration
- BCVOA Inc
  - o W-9 Form (if you currently have a vendor number from another sport a W9 is not required)
  - o ACH Request Form (only needed if you DO NOT have a vendor number)
  - o Security Badge (If transferee has a current FL State Uniform Badge, a new security clearance is not required. Security badge must be submitted during the application process.
  - o Provide a Letter from for last State sanctioning Association with confirmation of membership, years of services, test scores and any pertinent information to enable the FHSAA to properly classify your status.

All W9 & ACH Forms must be submitted to Dawn Turner @ dawn.turner@browardschools.com No later than the next day after submitting officiating application. Please make sure you include in the subject line. "Registration documents" If a member is not comfortable in sending W9 & ACH information via email, you should contact Dawn directly @ (754) 321-1202 to make other arrangements.

## **Training (Mandatory):**

All training dates will be posted on the Association website @ <a href="https://www.bcvoa.org">www.bcvoa.org</a> The training schedule will be updated with sites locations as it becomes available via Arbiter Sports.

All training sessions are mandatory to be eligible to officiate. Members should review the training dates on the website.

#### **Uniform:**
