# WRESTLING: Former C-F state qualifiers work as coaches to help rebuild Toppers' tradition

CAMBRIA – Joe Raymond and Jason Graham are former wrestlers for the Cambria-Friesland prep wrestling team.

The last time they wrestled, both of them made a trip to the WIAA Individual State Tournament in the 1992-'93 season, where Graham finished third at 275 pounds and Raymond took second at 160 pounds.

They were also joined by Jason Kok – who took sixth – marking the first time in C-F's history three wrestlers qualified for the state tournament.

Now Raymond and Graham are assistant volunteer coaches for C-F, trying to help rebuild a program that's been co-oping with Fall River, Pardeeville, Randolph, and Rio for the past few years.

When the co-op began, Rio was the host school. But with Rio not having a wrestling program this year, C-F is the host school.

"It's a big meaning for them to be over here coaching," head coach Jared Napralla said of Raymond and Graham. "Now that it's in Cambria, we've got an idea of carrying on a tradition."

And the tradition in Cambria is very rich, especially when you take a look at all the records in the wrestling room.

Raymond himself holds records for the best record in a season (36-1 in 92-93), career pins (66), career takedowns (235), and single-season takedowns (74). He's also second in career wins (113), second in single-season takedowns (66), and fourth in single-season pins (18).

Graham on the other hand isn't too far away on those lists. He's third with career wins (94), tied with Raymond for second in single-season wins (32), third in single-season takedowns (62) and third in career takedowns (142).

And both have some crazy stories about going to the state tournament.

"Coach (Patrick) Mootz and I, we've never been there," Napralla said about going to state as wrestlers. "We've never done that. This year, when we have these two guys, they've been there.

"They've worked hard and they've done their sacrifices. So when they say something, you better listen because they have the stories to back it up. Where me and coach Moots, we don't have that. ... When these guys talk, you better listen."

In fact, Napralla said these two legends of the program bring a lot of intensity with their "old school" way of thinking.

"They run more of a military gym because that's the way they were coached," Napralla said. "That's the way they were brought up. As wrestlers themselves, if you were told what to do, then you do it."

But this is Raymond's and Graham's first year coaching wrestling and they both have sons on the team, which is why they decided to join Napralla's staff.

Graham's son Kaden Graham is the team's 220-pounder while 120-pounder Max Raymond and 126-pounder Jacob Raymond are Joe Raymond's sons.

“It’s stressful and difficult,” Jason said of coaching your own son. “Kaden is a good athlete, you see that in football. But I think it’s actually worse being a parent.

“You see the head coach coaching your child, you can’t control what goes on. You can’t make him (do anything). He’s not a robot, he does his own thing. You have to accept what he does and try to encourage positively.

“It’s understanding the kids. When you’ve had the level of success that we’ve had, you tend to think that what you did way back when is the right way. And all we’ve done is learn that it’s probably not the right way. Now you have to tailor yourself around to (how things are done) today.”

That’s why Joe and Jason are left with the responsibilities of bringing the intensity of working out and pushing the wrestlers while Napralla and Mootz are in charge of applying the ins and outs of different techniques.

So far, it seems to be working, although both Joe and Jason are learning as the season continues.

“We have a great coach (Jared) over here,” Joe said Napralla who knows the moves in an out. “We have a lot to learn as coaches too. Even when you’re coaching, you’re still learning. The boys have to bear with us because this is our first year coaching too.

“We’re learning kind of how to do it right. If there is a right way.”

Joe said that every day, the stuff he and Jason used to do as wrestlers are coming back to them after being away from the sport for the last 20 years. But Napralla and Mootz have done a great job in helping them remember aspects of the sport and learning new things about the sport.

“They’ve obviously put in the work,” Kaden said of the new coaches. “They know what it’s like to get there. For all of us, that’s our goal is to get (to state).

“For us to have them to be there to work with us every day, it puts us one step closer to getting to that goal.”

Because it's a one-on-one sport, wrestling requires a great deal of mental toughness in addition to the necessary physical abilities.

Joe said when he was wrestling, he was often asked what his goals were. It was never good enough just to make it to the state tournament. He wanted to be a state champion.

And like Jason, he doesn't remember the wins. What sticks in his memory are the losses, like the one he lost in the 92-93 state championship match.

So with their past success in mind, Jason wants to turn the page and have success as a program again. He wants to help rebuild the Hilltoppers' rich tradition.

“To be honest with you, I don't like the added pressure that I do put on them as far as coaching,” Joe said of his contributions to the tradition. “It doesn't mean I'm going to run away from coaching, but I wish it wasn't that way.

“I think that's a natural feeling that they have. I can't really take that away. I can't take away the history, but we can teach them. We can do the best we can.”

That's where being a family comes in for a co-op that has kids from many different schools on the team. Because they all come from different communities, having a tight bond is important.

But Jacob said it's going well as a team.

“We've seen them before,” he said. “Like Cambria and Randolph, they share classes a lot. You see them around.

“It’s not very weird. You’ve seen them and you kind of know them. It helps us meet new people and we all get along.”

Getting along on the same team is very important too, because as a family, they have to be willing to talk to one another.

It’s important for the team to bond and have fun because if they don’t it’s very easy to just walk away from the sport.

“I actually worry about them losing their spirit, their wrestling spirit – as far as wanting to do this sport,” Joe said. “We’ve talked to coach about just keeping this fun. It’s not all just work, work, work and that’s part of the learning curve.

“And that’s why I say the coaches have been helping us a lot with that. We’ve talked about intensity. We’re trying to work that in with fun. These kids have to have some fun too. ... When I talk about family, don’t let them walk away. Try to keep the kids involved.”
