Driving Phase

Driving will be scheduled around the classes, Monday - Saturday.

Monday-Friday 7:00 AM – 3:00 PM Saturday mornings *ONLY IF* instructors are available.

Please do not sign up for this class with the assumption that your teen can drive on Saturday mornings.

Students must pass both the Classroom Phase and Driving Phase in order to receive a Blue Certificate.

Cost: \$705 (\$45 is nonrefundable)

Late Fee for payments made past the due date: \$25 additional

Exception Cost: \$45, please read below for an explanation for this cost. The \$45 is non-refundable.

NO REFUNDS WILL BE ISSUED WITHIN THREE WORKING DAYS OF THE CLASS START DATE

Exception Cost \$45: Students are deemed eligible to receive driver education funding from the State of Delaware if they are home-schooled, attend a private school with less than 25 sophomores enrolled, or who live in Delaware and attend high schools in other states. These students may take the alternate course for an administrative fee of \$45 and must be currently enrolled as a 10th grade student (as of 9/30/2024) or have completed their 10th grade year.

In order to be eligible to take the classroom phase of The Charter School of Wilmington's Driver Education Program, all students must have successfully completed 5 credits (2 in core areas), during the school year, and are required to email Mr. Casper a copy of their most recent report card prior to the first day of the class as proof of eligibility for the program.

<u>Students who turn 16 after February 12th, 2026 are not eligible to enroll</u> in the CSW SUMMER 2025 **Driver Education Program.** The Charter School of Wilmington will offer a Fall and a Spring Driver Education Program which may be better suited for their birthdate.

Students who choose to not take the Driver Education course during the school year, or who do not successfully complete the course during the school year, <u>must pay \$705</u> to take The Charter School of Wilmington's Driver Education Program.
