RENTAL AGREEMENT FOR HERD GT-77 BROADCAST SPREADER

The undersigned hereby agrees to the following terms and conditions for the rental of the Herd GT-77 Broadcast Spreader (herein after sometimes referred to as equipment) from Randolph County Cooperative Extension:

- Rental rates set forth below are payable when equipment is returned. The Renter had the option of paying up front in full or half up front and the remaining half at return.

o Rental Rates

- \$10/day in county use
- \$12/day out of county use
- \$30 for Friday-Monday in county
- \$36 for Friday-Monday out of county

1. Equipment is to be returned in the same condition as received. Any damage shall be reported at time of pick up or return and shall be the responsibility of the Renter.

2. Any damages or cost incurred from misuse of the broadcast spreader will be paid for by the Renter. Contact the Randolph Cooperative Extension office for instruction on how to proceed should the broadcast spreader require repairs while in the Renter's possession. The County will not pay the Renter for work he/she performs on the equipment or parts purchased without prior approval.

1. The Renter agrees to indemnify Randolph County as follows:

Indemnification — To the fullest extent allowed by North Carolina law but subject to the limitations in this Agreement, the Renter of the equipment (the Indemnifying Party) shall defend, indemnify and hold harmless Randolph County (the Indemnified Party) from and against any and all loss, cost, claim, liability, damage and expense, including, without limitation, reasonable attorney's fees, brought by or claimed by third parties (Claims), arising out of negligence, gross negligence, willful misconduct, intentional misconduct or any alleged liability by the Indemnifying Party, its employees, agents, or contractors in the use of, moving, transporting or otherwise arising out of the use of the equipment. The Indemnified Party shall notify the Indemnifying Party promptly in writing of any Claims for which the Indemnified Party alleges that the Indemnifying Party is responsible under

this section and tender the defense of such Claims to the Indemnifying Party. The Indemnified Party shall cooperate in a reasonable manner with the defense or settlement of such Claims at the Indemnifying Party's sole expense.

2. Scheduling will be completed by the Randolph County Cooperative Extension office with the pick-up & return of the broadcast spreader Monday-Friday between 8:00am and 5:00pm.
 - o Return the broadcast spreader & any associated equipment to Randolph Cooperative Extension in the same condition as received by 9:00am on the date due.
3. Contact the Randolph County Cooperative Extension office before using the broadcast spreader on any other person's property not a part of the original lease.
4. The broadcast spreader is NOT equipped to apply fertilizer.

5. The Renter agrees to thoroughly clean unused seed/fire ant bait from hopper and vacuum/wipe all mud, dirt and broadcasting materials from the spreader and hopper or pay a \$20.00 fee for cleaning the broadcast spreader upon its return. **DO NOT USE WATER**

6. All equipment (spreader/mounting brackets), toolbox, fire ant bait plates and manual is to be returned on the scheduled drop-off date.
7. Renter acknowledges and understands that the use of any equipment can lead to accidental injury, property damage, and in some extreme instances, death. In signing this Agreement, I, the Renter accept and assume all risks of injury and, for myself, and on behalf of my heirs, assigns, personal representatives, and next-of-kin, hereby release and hold harmless Randolph County, Cooperative Extension, its owners, officers, agents, servants, associations, employees, or any person or entity connected therewith from any costs or cause of action which I have or may in the future have as a result of injuries or damages sustained or incurred by me as a result of my use of the equipment covered by this Agreement.
