PLEASE NOTE

- 1) The cost of compulsory activities such as subject excursions, incursions and year level camps will be invoiced **regardless of the attendance**.
- 2) **The child in the highest grade** will always be treated as the first child. Second highest as the second child and further in the same manner.
- 3) **Tuition Fees do not cover**; bus, books, uniform, camp and subject specific fees.
- 4) **Foundation to Year 6 tuition fees** cover excursion and incursion fees **excluding** swimming, camp and gymnastics.
- 5) **Mid-year Exits** Where a parent or guardian wishes to exit a student from the College for the following term, Student Exit Form must be lodged 5 weeks prior to the start of the following term. Failure to provide the required notice will incur an additional 5 weeks school fee charge. Where a student's enrolment is terminated during a term, the College will be entitled to retain or be paid, as the case may be, that term's full fee.
- 6) **End-of-year Exits** Students who are not going to continue for the following year must lodge a Student Exit Form prior to 1st November 2024. Failure to provide the required notice will incur 5 weeks school fee charge.
- 7) **Bad Debt Policy** Legal action will be taken to recover any outstanding fees including lapsing of direct debit payments which may result in listing a family account as default credit.
