Methodology– is a section of the research that describes how the study was conducted. It includes the steps, techniques, and procedures used to collect, analyze, and interpret data. This explanation provides clarity to readers about the approach taken and ensures that the research can be replicated or validated by others.

Findings– is a part of the research report that presents the main results obtained from data analysis. This section serves to answer the research questions or achieve the objectives set out in the study. Findings should be presented clearly, systematically, and concisely, without excessive interpretation or in-depth discussion (which is typically covered in the Discussion section).

Research Implications/Limitations– provides an explanation of the impact and limitations of the research. This section helps readers understand the relevance of the study, its application in real-world contexts, and the constraints affecting the generalizability or validity of the research results.

Originality/Value– explains what makes the research unique and significant. Researchers need to demonstrate how their study contributes new insights or adds valuable perspectives to the relevant field of study. This could involve new perspectives, innovative approaches, current data, or solutions to specific problems.

INTRODUCTION (1000-1500 words)

Introduction should be started without indentation using Garamond 12 bolded capital letters. Subheading is limited by two spaces within the body of the article. Please make the page setting of your word processor to A4 format (8.27x 11.69 inches); with the margins: bottom 3 cm (1.18 in) and top 3 cm (1.18 in), left 3 cm (1.18 in) and right 2.5 cm (1.47 in). For the body of the paper, please use Garamond 12, 1,5 spacing. In the introduction inform the problem of study, use theories. The contents of the paper should be in the following: (1) title of paper, (2) author names and address, (3) abstract, (4) keywords, (5) introduction, (6) discussion and analysis, (7) conclusion, (8) acknowledgement (if any), (9) bibliography. Do not number your paper. All text, figures and tables must be in English for English articles, and must be in Arabic for Arabic articles. Should always be written in with the fonts Garamond 12, especially also in the figures and tables. The length of the article is 4000-6,000 words including all pictures, tables, nomenclature, references, etc.

METHOD (500-1000 words)

Method consists of description of research type, data collection, data source, data type, and data analysis. It is written in a paragraph form.

RESULTS AND DISCUSSION

Findings (can be in form of subheading) (1500-2500 words)

Inform a number of important data (original) fields which are obtained from the questionnaires, surveys, documents, interviews, observations and other data collection techniques. It can be completed with a table or graphic to clarify the result.

All figures and tables should be centered and numbered consecutively. Tables (refer with: Table 1, Table 2,...) should be presented above the table contained in center alignment. A descriptive title should be placed after the table title (refer with: Table 1, table 2,...) above each table. The source of the table should be placed below the table in right alignment. Example:
