1. No race applications will be accepted after **4 September 2026**.
2. Applications will only be accepted on this form. **Partly completed forms will NOT be accepted.**
3. Your **CHOICE** of dates may be denied, and an **alternative** date offered.
4. Applications **without** three (3) choices of dates will not be accepted.
5. It is the responsibility of the club to ensure that the association has received its application.
6. Any Race application received from a Club that is not in good standing with KZNA or ASA will be deemed as an invalid application and will be not considered.
7. Clubs which are **NOT in good standing** at the time of publishing the Fixture Booklet, or at any time before the event will NOT be allowed to host a league in 2027.
8. Clubs that have **CANCELLED LEAGUES** in 2026 **without a valid and acceptable reason** will not be allowed to host a league in 2027.
9. The Club hereby agree to forward composite results, temporary licence fees and race reports within 21 days of race to KZNA office. Failure to comply with this Rule constitute a disciplinable offence.
10. **KZNA** Logo and other sponsors logos to be on all flyers/entry forms.
11. Any Club applying for hosting a Race is required to send a flyer for **APPROVAL** before distribution to the public and media.
12. **The details provided for the contact person will be posted online and on the fixture booklet.**
