2 LITERATURE REVIEW

This section includes a literature review of relevant theories, concepts, and/or models as a reference for answering research questions or research objectives. The literature review should utilize the latest reference sources, particularly scientific journals, dissertations, theses, textbooks, and other relevant materials.

3 RESEARCH METHODS

The research method describes the design of research, scope or object, main materials and tools, location, data collection techniques, operational definitions of research variables, and analysis techniques.

4 RESULTS AND DISCUSSION

This section presents the research results. Research results can be supplemented with tables, graphs (images), or charts. The discussion section presents the results of data processing, interprets the findings logically, and relates them to relevant references.

4.1 Image and Table

Each figure must be captioned below the figure, and tables must be captioned above the table. Captions should be written in lowercase letters except for the first character of each sentence. 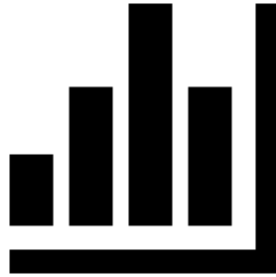


Figure 1. Example for figure.

4.2 Citation and References

References should be written according to IEEE standards. Write down the references used in the main paper. Do not include references that are not used as references in writing the manuscript. Every reference listed in the Bibliography must be cited in the body of the article. We recommend using reference management software such as Mendeley and Endnote. References should be publications from the last five years (>80%), except for primary references

(80%). References from textbooks should be minimized (<20%). Each manuscript must include a minimum of 15 references and should contain citations from articles published in this journal to ensure relevancy.

The conclusion contains a brief summary of the research results and discussion. The conclusion section is written in paragraph form rather than bullet points or numbered points. Recommendations or suggestions for further research may also be included in this section.
