**ASSUMPTION OF RISK AND WAIVER OF LIABILITY RELATING TO COVID-19**

I understand and acknowledge the continued impact and risk of COVID-19. As a result, I understand the recommendations provided by federal, state, and local governments and federal and state health agencies.

The Nantucket Public Schools Athletic Department has put in place preventative measures to reduce the spread of COVID-19 and has met the current recommendations of the Centers for Disease Control (CDC) and the Commonwealth of Massachusetts Department of Public Health whose recommendations were based upon scientific data regarding COVID-19.

However, the Nantucket Public Schools Athletic Department cannot guarantee that students will not become infected with COVID-19. By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) may be exposed to or infected by COVID-19 and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

I understand that the risk of becoming exposed to or infected by COVID-19 at the Nantucket Public Schools Athletic Department facilities may result from the actions, omissions, or negligence of myself or others. I voluntarily agree to abide by all Nantucket Public Schools Athletic Department rules, regulations, and protocols and understand that the Nantucket Public Schools may revise its rules, regulations, and protocols at any time based upon updated recommended guidance and protocols issues by the CDC and/or the Commonwealth of Massachusetts and further agree to comply with the Nantucket Public Schools Athletic Department's revised procedures prior to utilizing the facilities, services, and programs of the Nantucket Public Schools Athletic Department.

I understand and agree that my child(ren) will not participate or utilize the facilities, services, and programs of the Nantucket Public Schools Athletic Department if my child(ren) have been confirmed to have contracted COVID-19.

I understand and assume all of the foregoing risks and accept sole responsibility for any injury to myself (including but not limited to personal injury, disability, and death), illness, damages, loss, claim, liability, or expense, of any kind, that my child(ren) may experience or incur in connection with the Nantucket Public Schools Athletic Department.

On my behalf, I hereby release, covenant not to sue, discharge, and hold harmless the Nantucket Public Schools, the Nantucket Public Schools Athletic Department, its employees, agents, and representatives, of and from the claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating to employment or access/use of such facilities.

I understand and agree that this release includes claims based on actions, omissions, or negligence of Nantucket Public Schools Athletic Department, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after access/use of Nantucket Public Schools Athletic Department facilities.
