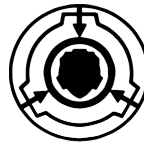
**History:**

Reassignment request has been submitted to the Committee for the position of Site Advisor within the Foundation.

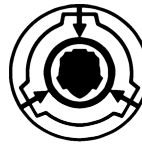
