The manuscript must be original, has never been published before or is in the process of (in the process) other publications. The body of the manuscript (including abstracts and bibliographies) is written in a minimum of 3000 words and a maximum



of 6000 words, in A4 paper size with 1.15 spaces, Arial font size 12. The title of each part must be bolded while the subsections are in italic form. Average left 2.5 cm, 2.5 cm right flat, 2.5 cm lower limit, and 2.5 cm upper limit. Quotations are written by following the APA (American Psychological Association) standard.

2. Research Method

This sub should contain sufficient technical information so that the method can be repeated by others well. Describe conclusively that the method used is a new method and if necessary use a table

3. Results and Discussion

3.1. Results

This sub-section contains the results of research. Results can be presented in the form of text, tables, and interpretations accompanied by reported results. The tables are accompanied by sequential numbering and should be quoted in the body text.

3.2. Discussion

The discussion can be either in separate sub-section or integrated within the result section. The author should discuss the finding from the research with relevant literature.

5. Conclusion

The conclusion must be present throughout the study findings. Writing the conclusion must be simple and concise sentences so easily to be understood by the reader. Accompanied with new understanding/perspective/insight refers to the research results obtained.

Acknowledgements

Acknowledgements can be delivered to the parties who have helped research and completion of the writing of the manuscript. These parties can act as mentors, funders, providers of data, and so forth.
