Login Credentials

This service is only designed for the students of SCET(Shadan College of Engineering and Technology) and they can access it via entering their roll number allotted by the college, when they enter roll number we use "regex" pattern to match all credentials of a roll number whether matching with college allotted roll number and if it matches then user is allowed else not. And there is no place to store user's roll number in our service, it's just for the confirmation whether the user belongs to SCET or not.

Log Data

I want to inform you that whenever you use my Service, in a case of an error in the app I collect data and information (through third party products) on your phone called Log Data.
