### Information Provided by You

- **Photos or images** used to generate AI-based toy avatars
- **Email address** (when you contact us or interact via support or feedback)
- **Payment information** (if applicable, for purchases or subscriptions)

### Information Collected Automatically

- **Device data** (e.g., IP address, device model, OS version, device language)
- **App usage data** (features used, session time, actions taken)
- **Analytics data** (used to improve user experience and app performance)
- **Crash logs and diagnostic info** (to help improve app stability)

Note: ToyPack accesses your photos only when you explicitly choose to upload or capture one. Images are processed securely and not stored after toy generation unless necessary for app functionality.

## 2. How We Use Your Information

We process your data to:

- Provide and operate the app and generate AI toys
  - Enable purchases, subscriptions, and restore previous purchases
  - Improve the app experience and personalize features
  - Respond to your feedback and support requests
  - Notify you about important updates or changes
  - Monitor usage trends and optimize performance
  - Comply with applicable laws and legal obligations

### 3. Will Your Information Be Shared?

We do **not sell** your personal information.

We may share your data only in the following cases:
