- Board reports
 - Langendorf: ICE came to community 8 or 10 years ago, community was fearful; students felt the same way today, comforted that there was support; hope familis are informed about what services are available; Tiger Market food pantry will start during lunch next Monday
 - Hixson: Refuge center is doing know your rights workshops
 - JIT: had sessions with precipals and immigration attorney, Lucia is taking the lead; more know-your-workshops planned
 - JIT: in 2016 district did the same thing; attendance didn't drop because district was proactive; not having school today gave a buffer day; administrators will watch for drops and work with family liaisons
 - Poulosky: must schedule training because district has intensive schools (ISBE designation), might be a remote option; next session is on school improvement
- Recognition: Congratulations to three students
- Student Ambassador report:
 - Lunches quest food has not been up to quality as promised; quality was good at the
 beginning but it has declined; not enough food for juniors and seniors who eat last; pizza
 and chicken sandwiches; Quest replied that the run out of food only happened at the
 end of the semester; but Citlaly said it happened more
 - District started monthly meetings with quest and can give them feedback
 - Bathrooms are still neglected; stall doors don't close; students use them to skip class;
 two bathrooms only have 1 working sink, causes lost class time
 - Decorating graduation caps; seniors want to; district 4 can; limits creativity; students want answers as to why they can't decorate
 - Habitat for Humanity fundraiser gained popularity for boys volleyball; might have to make a tough decision about what to fund; Mr Waller and Mr Guzman are looking into it
- Administrative personnel items (Angi Franklin)
 - Posted for 2 middle school administrative leadership
 - Each candidate interviewed: at level one interviewed 5 candidates, 3 advanced to level 2 interviews
 - All 4 interview committees recommended Ms. Amani Carr as first 6th grade center administrator and Mrs. Melissa Kearns as 7-8 principal

- Roll call: unanimously approved
- Illinois association for administrators Vision 2030
 - Tonight just discuss
 - Second time creating an advocacy framework for public education
 - Funding model, college and careers initiatives came out of vision 2020
 - Collaboration of many organization representing administrators at all levels
 - o In Nov 2012; developed Vision 2020 that sparked legislative action
 - In aftermath of COVID, immense challenges; need a new system for diverse learners, teacher recruitment, student opportunity and predictable funding
 - Input from over 1000 stakeholders throughout Illinois
 - Mandate Relief: Illinois school code has doubled since 2000
 - JIT: Unfunded mandates without enough money or minutes in the school day to do it all
 - Future focused learning
 - Future driven skills
 - Safety and well being
 - High quality, diverse teacher pipeline
 - Promote curriculum and instructional flexibility to meet local needs
 - Some districts don't use all the money allocated to them
 - Shared accountability
 - Reform assessment system to be timely and useful
 - Reform to provide more local flexibility provide indicators that define student success
 - Reform mandate process for local flexibility
 - Predictable funding
 - Protect integrity of evidence-based funding formula
 - Set formula based on Tiers (USD is Tier 1)
 - Three tiers based on local funding ability (tax base)
 - Tier 1 can't fund needs based on local sources
 - Based on extensive documents stating resources available, how funding is used, what are goals... very detailed formula
 - Establish equitable statewide funding sources for capital and safety
 - Like metal detectors and vaping sensors
 - Unit 4 has a different tax base
 - Enhance financial flexibility
 - Tax caps (cap in the increase in what the school can request)
 - Key goals
 - Keeping students safe
 - Keeping high quality educations in front of students
 - Enhancing post-secondary success
 - Portrait of a graduate group starting in USD
