

TERMS OF SERVICE (6/16/25)

DISCLAIMER:

I do **NOT** allow my art to be used for NFT or AI training purposes.

I do **NOT** allow my artwork to be used for merchandise, streaming, promotion, etc unless commercial rights have been purchased.

I DO NOT DRAW:

Proship

Detailed backgrounds

Mecha

Anything I (the artist) am uncomfortable with. I reserve the right to decline any commission based on my comfort, whether it relates to skill or personal comfort.

I DO DRAW:

Anything like the pieces you see on my socials

Furries (all though they are not my specialty)

Fanart

Light gore

Roblox avatars

Some armor (the more detailed the armor is, the more money I will request)

Nudity, *Suggestive* & NSFW work (You must be 18+ to request)

USER AGREEMENT:

By commissioning me (the artist), you (the commissioner) agree to abide by everything under my terms of service.

You agree to use my commissioned work for personal purposes unless the commercial add-on has been paid (2x the original price).

PAYMENT:

DEADLINE: Unless a deadline is stated, the art will typically take up to 2 weeks before it is completed.

If an earlier deadline is required, notify the artist (myself).

- An extra \$10-\$15 dollars minimum will be charged.
- Expedited production costs will vary based on the complexity of the piece AND how soon the piece needs to be completed from the time it was ordered. (Lineless pieces REQUIRE two weeks minimum.)

PAYMENT METHODS:

The commissioner agrees to pay the artist in full via Paypal

The piece will be provided in full immediately after completion*

* = UNLESS additional payment is required after chargeable changes or requests have been made. (SEE: Revisions)

OR

For commissions priced \$50+

The commissioner has the choice of paying half of the decided price at the beginning of the project and half at the end of the project.

The piece will be withheld until the second half of the payment is received.

CANCELLATION:

If the commission is canceled after the base sketch has been completed and a progress picture has been sent, the commissioner agrees to pay 1/3 of the original price and the artist agrees to refund 2/3 of the original price.

Note: Rough composition sketch "composition sketch" or "rough sketch". Is what I will show you at the VERY beginning!

Rough sketches will be sent to the commissioner, which the commissioner may choose from. Sketches may be combined! (NOTE: THESE SKETCHES WILL BE LOWER QUALITY AND LIKELY WATERMARKED FOR MY OWN SAFETY.)

Note 2: Base sketch. The clean sketch that comes after a composition has been chosen and refined.

Upon reaching later stages, no refunds will be provided unless absolutely necessary. Necessity will be decided by myself.

Past completion, I DO NOT offer refunds AT ALL. So please let me know if you would like to cancel *BEFORE I FINISH*. IF YOU DO NOT, THAT IS ON YOU.

REVISIONS:

The artist agrees to submit *AT LEAST THREE* work-in-progress images from the commission's beginning, middle, and end, and any extra upon request.

(Do keep in mind that I [the artist] am human, I like to do things outside of commission work, so don't expect major progress every single day!)

- The artist is willing to make up to **ONE MAJOR revision** free of charge during the WIP stage, after the base sketch has been sent and agreed upon. (+\$5 for each revision afterward)
- When the piece is near-finished (base color only) major revisions are no longer free of charge.
- Prices will vary depending on how large the revision is (+\$10 minimum).
- The artist is willing to make up to **FIVE MINOR revisions** free of charge during the WIP stage, after the base sketch² has been made and agreed upon. (+\$5 for each revision afterward) When the piece is near-finished (rendered) minor revisions are no longer free of charge.

Major revisions include (but are not limited to): Body positioning, full limb positioning [arm/leg/tail/wings/etc.], hair positioning, head positioning, the subtraction of a character.

Minor revisions include (but are not limited to): hand or foot pose (not including the whole limb), facial expression, orientation of the piece (left facing vs right facing)

DO NOTE THAT SOME CHANGES WILL BE DETERMINED AS MAJOR OR MINOR ON A CASE-BY-CASE BASIS. I WILL WORK WITH YOU TO MAKE THE PROCESS AS BENEFICIAL AND SMOOTH AS POSSIBLE!

USAGE/DEFINITION OF COMMERCIAL USAGE:

Commercial use includes use of my art for anything that will generate income or involves financial transactions (Direct [selling] or Indirect [Marketing or advertising]).

Specific examples include but are not limited to; merchandise, streaming assets [Twitch, YouTube, Kick, Facebook, TikTok, Spotify or otherwise], marketing, promotional content, books for sale, TV commercials and/or programs, advertisements, etc.

- You may repost the commissioned work as long as you credit me and include the watermark!
- You may use the work for non-commercial (non-profitable) use as an icon, banner, background, etc. **I simply ask that you credit me somewhere and/or link anyone who asks about my work to my socials (@Severalcherries on all platforms)!**

YOU WILL BE BLACKLISTED UPON HEAVY VIOLATION OF MY TERMS,

I RESERVE THE RIGHT TO DENY OR NOT ACCEPT A COMMISSION FOR WHATEVER REASON. IF YOUR BEHAVIOR IS NOT UP TO PAR (GENERALLY RESPECTFUL) OR IF YOUR REQUEST DOES NOT SUIT MY STYLE OR TERMS. PLEASE RESPECT THIS, THERE ARE OTHER AMAZING ARTISTS TO SUPPORT.

I RESERVE THE RIGHT TO POST MY ARTWORK AND/OR USE MY ARTWORK (YOUR COMMISSION) FOR MY PORTFOLIO UNLESS DISCUSSED! *PLEASE* LET ME KNOW IF I AM NOT ALLOWED TO POST YOUR COMMISSION.
