MassHealth

- Note that LICSW's enrollment as "non-billing provider" with MassHealth does not affect being able to contract with the managed care plans below in order to treat MassHealth recipients.

 - Fallon
 - All 3 of the above are connected with Carelon (WellSense will be separating from Carelon and insourcing BH in 2026)

Direct MassHealth

- Some very few MassHealth plans are billed directly through MassHealth
 - This includes MassHealth plans secondary to commercial insurance
 - Providers can now contract as fee-for-service (FFS) with MassHealth
- MassHealth secondary to Medicare
 - Therapists can contract with Medicare and as "QMB provider" to accept this type
 - Some have specialized versions through OneCare providers contract directly with these plans
 - Commonwealth Care Alliance
 - Tufts One Care (formerly Tufts
 - United Healthcare Connected

• Medicare

- o includes many versions of Supplemental, Advantage, etc.
- It is generally required to be contracted with Medicare and the secondary/supplemental insurance type
- Must enroll or officially opt out in order to see Medicare clients
