Privacy Policy

This Privacy Policy is here to better serve those who are concerned with how their information is used online. The following describes what type of information we collect, what it is used for, and the measures we take to protect it.

1. Definitions

"Company", "We", "I", "Our", or "Us" means Between Soulful Hearts and www.BetweenSoulfulHearts.com which is owned by The Aligned Journey, Inc., dba Between Soulful Hearts.

"Content" means any and all written, visual, video, or audio information contained on the Site, including, but not limited to, any and all emails and communications of any form received from Dr. Diane Robertson, (formerly Dr. Diane Abdo), Between Soulful Hearts (owned by The Aligned Journey, Inc.), or www.BetweenSoulfulHearts.com, and any and all written or downloadable material purchased, viewed, or otherwise offered on www.BetweenSoulfulHearts.com such as blog posts, graphics, designs, documents, information, downloadable materials, video, audio, templates and materials.

2. Company Statement:

3. What kind of Personal Information do we collect?

Between Soulful Hearts is committed to protecting your Personal Information. We will only collect or use your Personal Information in accordance with the Privacy Policy herein.

Personal Information You Provide:

When using the Site, and filling out forms, purchasing products, providing comments, or contacting us, you may be asked to enter your name, email address, website address, mailing address, payment or credit card information. We use this information to deliver the product purchased, or information requested, to improve the performance and applicability of the Site, and to provide you with educational content, newsletters, promotions, and special offers.

The Site may include interactive areas such as comments, blogs, forums, emails, virtual discussions, bulletin boards, or other communication features. Any information you voluntarily disclose in these areas may be viewed, collected, or used by others. We do not control and are not responsible for the conduct, communications, or actions of users within these interactive environments.

Personal Information Automatically Collected: Data provided voluntarily, such as names, email addresses, phone numbers, and physical addresses, email list, newsletter, social media posts, blog posts, courses, coaching services, guides, eBooks, forms, worksheets, workbooks, website materials, video, and/or educational information, IP address, browser type, operating system, device type, screen resolution, how long you stay on a page, pages visited, links clicked, scroll depth, search queries within the site, purchase history, items left in shopping carts, saved preferences and/or any other information that will help improve the user experience and/or site functionality.

Through use of the Site, the Company may use data collection technology, such as Google Analytics, Jetpack, etc. (hereinafter referred to as the “Data Collection Companies”) to collect information related to your use of the Site. Generally speaking, this includes information about your geographic location and Site behavior. 6. How do we use your Personal Information?

When using the Site, Courses, Services, and/or Products, we may use the Personal Information we collect from you when you register, make a purchase, sign up for our newsletter, respond to a survey or marketing communication (typically by email), browse the Site, or use certain other Site features in the following ways:

- To personalize your experience and to allow us to deliver the type of content and product offerings in which you are most interested.
- To improve our Site in order to better serve you.

7. Do we share your Personal Information with anyone?

In general, we DO NOT sell, trade, or otherwise transfer to outside (third) parties your Personal Information for marketing or advertising purposes, except for the following purposes:

- In order to comply with an investigation, law enforcement inquiry, government entities, courts, or other third parties as required or allowed by applicable law, such as for legal and/or safety purposes.
- Third-party service providers that provide products, tools, platforms or services to us, such as email-list building, website management, customer service, account maintenance, and performing other activities and services related to the management and running of our company.
- Social media platforms such as Facebook, Instagram, Twitter, Pinterest, and other similar sights that offer functionalities and services to use their services through our website (i.e., pinning an image to Pinterest, sharing a link to Facebook). If you use those functionalities on the Site, your information will be shared with those platforms to complete those functions and activities.

It's also important to note that we DO NOT allow third-party behavioral tracking, and we are not responsible in any way for attempts by third parties to track behavioral or personal information.

8. How do we protect your Personal Information?

We aim to make your visit to our Site as safe as possible. The Site uses commercially acceptable methods of security protection to protect your information, and may use, when we deem appropriate, Sitewide HTTPS/SSL, WAF, MFA/2FA, Automated Updates, Backups, Data Sanitization and/or any other methods we deem fit for maintaining site security and for protecting your data. The Site is scanned for security breaches using Vulnerability Management, Endpoint Detection and Response (EDR), and Extended Detection and Response (XDR), or any software and scans that improve site security.

We also use an SSL certificate and never transmit your credit card information by email.

Your Personal Information is contained behind secured networks and is only accessible by a limited number of persons who have special access rights to such systems, and are required to keep the Personal Information confidential. By viewing, using, or purchasing on or from the Site, Courses, Services, and/or Products, you acknowledge that The Aligned Journey, Inc., dba Between Soulful Hearts and its staff and independent contractors may access your Personal Information.

In addition, all sensitive credit card or payment information you supply is encrypted via Secure Socket Layer (SSL) technology. And/or, we may accept payments using a gateway provider such as PayPal, Woo Commerce, Square, Stripe, Shopify, or other providers as we deem appropriate. We implement a variety of security measures when a user places an order to maintain the safety of your Personal Information. These transactions are processed through a gateway provider and are not stored or processed on our servers.

9. Do we use 'cookies' or social media pixels?

Cookies. We, and third-parties as described in Section 7 herein, use cookies and collect information from the computer, mobile phone, or other device you use to access the Site, read our emails, or view our advertisements. This information is automatically collected. Cookies are small data files that a site or its service provider transfers to your computer's hard drive through your Web browser (if you allow) that enables the site or service provider's systems to recognize your browser and capture and remember certain information. For instance, we use cookies to help us remember and process the items in your shopping cart. They are also used to help us understand your preferences based on previous or current Site activity, which enables us to provide you with improved services. We also use cookies to help us compile aggregate data about Site traffic and Site interaction so that we can offer better site experiences and tools in the future.

We use cookies to:

- Compile aggregate data about site traffic and site interactions in order to offer better Site experiences and tools in the future. We may also use trusted third-party services that track this information on our behalf.
- To personalize your experience and better understand customers' preferences for our marketing, communication, product development, and business purposes.

11. Password Privacy:

16. CAN-SPAM Act of 2003:

- We WILL honor opt-out/unsubscribe requests quickly.
