ever lose a buyer

A former RCMP officer is one of Calgary's leading real estate salesmen after breaking into

the industry at age 54.

For Archie Evanson, 60, real estate sales followed a five-year stint with the RCMP and 20 years in life insurance sales. The "sugar beet kicker" from Taber, Alta., approached P. J. Toole and Cote Ltd. after wife Hilda convinced him he'd enjoy it.

"I liked the life insurance business," Evanson said, "but real estate is more demanding. You always have to be in touch with your product and

market."

Evanson sold "well over \$1 million" worth of property to become Toole and Cote's top salesman in May, but he doesn't show up on the top 50 list for the Multiple Listing Service.

Branch manager Dorothy Larson explains this is because "Archie has had good success selling his

own listings.

The MSL service is a co-operative producing listings from many of the city's real estate firms but Evanson sells most properties before that becomes necessary.

He admits to making a lot of money.

"People start saying realtors make a lot of money," Evanson said, "but if they followed a good one around for 30 days they'd be dragging their butt.'

A typical day for Evanson begins in the office by 8 a.m. He may begin by doing some "farming," making contracts with potential customers, and

then pick up an out-of-town couple at the airport to begin showing houses. Evanson says he enjoys working with people but always wants to control the sale.

"I never lose a customer," he said.

To keep them in sight, Evanson often brings them to his home for lunch while he sets up afternoon appointments in his den.

"I'm 6'2 at 210 lbs., so I don't need lunch," he

laughs.

He has sold a number of couples on the first house they look at, but has shown up to 40 to some.

"I still got the sale," he said.

Evanson says the key to his success is an attitude his father taught him.

"He made work fun, and if you don't enjoy what

you're doing, I feel sorry for you."

He agrees Calgary is a good place to be in real estate but emphasizes the importance of hard

"You've got to get yourself up "10 to 15 times a day, and you must keep good records. You can

starve in Calgary like anywhere else."

He's consistently been in the top three of his branch and is a member of MLS million-dollar club, as well as a VIP member for the past two years. Evanson credits his ability to listen and be trusted for his spot at the top of the heap.

"Remember that in any sales field, 80% of the sales will be made by 20% of the people," he said.

It seems the only thing able to ruin Evanson's usually pleasant disposition is the mention of retirement.

"Why should I retire when I'm 65? I'll be at my peak!"
