A Plan to Rebuild America

Preamble: The Call to Revolution

We are in the middle of a political revolution, born from desperation that has been growing for more than 50 years. After building the greatest middle class in history, our leaders presided over the greatest transfer of wealth in history—from the paychecks of working Americans to the balance sheets of the wealthy few.

This was not an accident. It was a choice—made and defended by leaders of both parties. Republicans abandoned the rule of law and empowered authoritarianism. Democrats, beholden to the same corporate donors, failed to provide a meaningful alternative. Together, they offered "normalcy" as the cure, when it was "normal" that created the crisis.

The official narrative is false. We commit to governing based on the reality of American life. This crisis wasn't caused by immigrants, marginalized communities, or the poor. It was produced by systemic choices. Our plan fixes systems, not scapegoats.

Part I: The Diagnosis — The Ten Shared Realities

We must agree on the reality of the crisis before we can rebuild.

- 1. **Our Economic Measurements Ignore Decline:** Metrics like GDP, Real Wages, and official inflation create the illusion of progress while ignoring the affordability crisis and masking the erosion of our industrial base.
- A Stable Life is No Longer Affordable: Housing, healthcare, education, and childcare
 have systematically outpaced wage growth. Families survive through debt and sacrifice,
 not sustainable wages.
- Position at Birth Matters More Than Actions in Life: Inequality is entrenched because starting lines are unequal. Decades of diverted growth concentrated wealth and power at the top.
- 4. **America Can't Build Anymore:** Our capacity to execute complex projects has collapsed across both government and industry.
- 5. **Essential Sectors are Structured for Extraction, Not Function:** Healthcare, housing, and education prioritize profit over service. These systems must be restructured, not subsidized.
- 6. **Industrial Sovereignty Has Been Surrendered:** We dismantled our industrial base and no longer make what we need, creating dangerous dependencies.
- 7. **Governance is Captured and the Rule of Law is Unequal:** Corporate capture and a two-tiered justice system leave elites immune from consequences.
- 8. **Democratic Legitimacy is Collapsing:** Congress abdicated its responsibilities, the state outsourced core functions, and gerrymandering and corruption eroded representation.

- Systemic Collapse Requires Systemic Reconstruction: Incrementalism cannot solve structural failure. Either we rebuild with democratic supermajorities or we leave the door open to authoritarianism.
- 10. **No One Can Do This Alone:** Transforming this reality requires unity, common cause, and a movement larger than any individual.

Part II: The Ten Commitments: A Blueprint to Have Nice Things

Once elected, the Coalition will work together to implement the following pieces of legislation to benefit ALL Americans:

I. To Make Life Affordable

- The American Health Liberation Act: Establishes a single-payer, Medicare for All system, a Health Worker Coalition, public clinics, and a public drug manufacturer to produce essentials like insulin at cost.
- 2. **The Housing for All Act:** Creates a Public Housing Production Authority to build 10 million high-quality, mixed-income homes in 10 years.
- 3. The American Capacity and Independence Act: This act restores our nation's industrial might by creating the American Building Authority (ABA). Modeled on the Reconstruction Finance Corporation (RFC) for finance and the War Production Board for execution, the ABA will fund and coordinate all projects under this Contract. It will be led by a proven industrial leader in the mold of William S. Knudsen—an engineer or a builder, not a politician or a Wall Street banker. The ABA will be empowered to cut through the red tape and endless lawsuits that have paralyzed American progress.
- 4. **The Universal Childcare and Family Support Act:** Establishes a network of high-quality, publicly-owned, and locally-operated childcare and pre-K centers.

II. To Restore Worker Power & Dignity

5. **The Worker Power and Dignity Act:** Guarantees the right to unionize via card-check, bans anti-union "right-to-work" laws, and establishes first-contract arbitration.

III. To End Corruption & Impunity

- 6. The Equal Justice Act: This act establishes a new Office of Public Accountability with a "war board" mentality focused on ruthless efficiency and anti-corruption. It will ban stock trading for all members of Congress, their families, and federal judges. It will establish a "Builder's Bounty" for public auditors who stop waste and give the government power to claw back fees from consultants who cause delays and budget overrups
- 7. The Public Equity Act: Every corporation receiving significant public funds must yield

a proportional equity stake to a national American Sovereign Wealth Fund, creating a public dividend for all Americans.

IV. To Restore Our Democracy

- 8. The Safe and Just Communities Act: Makes a historic investment in data-proven strategies that stop violence before it starts, including Community-Based Violence Intervention (CVI) programs.
- 9. **The Democracy Restoration Act:** Ends partisan gerrymandering, guarantees automatic voter registration, and establishes an honest "American Affordability Index" that tracks the real cost of essentials against wages.
- 10. The Common Sense Immigration and Border Security Act: Secures our border with modern technology for safe and orderly processing and creates a clear, simple, and fair process for work visas and an earned path to legal status.

Part III: The Pledge (12 Steps)

Building Power (Voting as a Bloc):

- 1. Vote in unison for the Ten Legislative Priorities.
- 2. Vote in unison against authoritarian executive overreach.
- 3. Oppose and work to defeat politicians who block these priorities regardless of party.
- 4. Refuse contributions from corporations/PACs lobbying against priorities.
- 5. Support only leaders who commit to floor votes on the Ten.

Accountability and Rule of Law:

- 6. Vote to ensure equal protection under law.
- 7. Impeach justices or presidents who violate ethics or core constitutional principles.
- 8. Remove Fed governors who fail to prioritize full employment.
- 9. Reject budgets that increase military spending while domestic needs go unfunded.

Transparency and Competence:

- 10. Support accurate data collection on working families' conditions.
- 11. Refuse all stock trading while in Congress.
- 12. Reject bills without at least 72 hours' review.
