Treatment: Reading Recovery (RR) is a one-on-one reading intervention for students in the bottom 20% of reading achievement in each first grade class, see https://readingrecovery.org/. At this district, 15 schools implemented the program in 2017 with an average of 13 students treated per school over the year (195 total, with 8-26 at each school). Each student was pulled out from class 4x/week for 30 mins each time over 18 weeks to work with a trained RR teacher. Schools had 1-3 RR teachers (1.64 average, total 24 in district) each serving an average of 8 students. Teachers are supervised and trained by a Teacher Leader who serves all schools but is physically based at Site T14 which has a special 1-way glass

observation room used for training RR teachers. TLs and RR teachers each participate in initial training during their first year delivered by a local university. They must also participate in ongoing PD every year. Each year, the TL and one RR teacher per school attends the annual RR conference delivered by Reading Recovery Council of North America (RRCNA). The average tenure of RR personnel is 7 years.

Control: Fast ForWord Reading (FFW) is an online reading program, see https://www.scilearn.com/program/. To create a control group, the district found a close match for each T student at 15 other primary schools in the district. These students engaged in FFW for the same amount of time that the T students participated in RR. 8-13 students in each school were pulled out of class simultaneously to use FFW in a classroom supervised by an instructional assistant. Each student used a laptop with headphones and an audio splitter to allow the instructional assistant to listen along time to time. The instructional assistant received 2 hours of online training in how to support students using FFW and review their progress.
