- Truck oil changes are recommended to be done at 10,000. Will need to stay on top of that timeline.
- Would undercoating the new truck be worth it? Possibly, could look into it.
- The new truck is built, just waiting on a body. Hopefully, Jeremy will be able to use it for the upcoming winter.
- The Highway job posting should be posted in more places, such as Indeed. Jordan will look into posting it elsewhere.
- If it's still available, Jeremy would like to go with the used VENTRAC that was quoted. Jordan will send the info to the board.
- Since Jeremy is the only crew member right now, (potentially for the winter) the board/Jeremy could talk to neighboring towns to see if we could work out an agreement with winter plowing. Something that could benefit both Towns?

#### Member concerns/Other business:

Board reviewed the Sheriff's report. There was more activity in August, compared to July.

At the next meeting, Brooks would like to add youth representative discussion to the agenda.
