## Waiver of Liability, Assumption of Risk, and Indemnification Agreement

### Introduction

This Waiver of Liability, Assumption of Risk, and Indemnification Agreement ("Agreement") is entered into by and between the user of any Product sold by Clear Above LLC or related accessories ("Product") ("I" or "User") and Clear Above LLC ("Company"). By purchasing and/or using the Product, the User acknowledges that they have read, understood, and agreed to the terms of this Agreement.

**Important Notice:** This Agreement is legally binding. If the User does not agree to its terms, the User must not use the Product and must return it to the original place of purchase.

#### **Version and Effective Date:**

This Agreement was last updated on **March 3rd**, **2025** (Version 1.0). Future updates will be indicated with a revised version number and effective date.

## Acknowledgment of Risks

The **Product is not a safety device**. It is intended solely as an **aid to the User** and does not remove or replace any part of the User's responsibility to:

- Maintain a safe distance from other aircraft and objects,
- Avoid collisions, and
- Ensure the safety of the balloon and all occupants.

The User acknowledges and understands that the use of the Product involves inherent risks, including but not limited to:

#### **Product-Related Risks:**

- Fire hazards may arise during normal operation, improper battery charging, misuse, water exposure, battery defects, impact damage, aging, or abuse. These risks could lead to fire, personal injury, death, and/or property damage.
- Electrical malfunctions may occur due to worn insulation, faulty components, or improper maintenance.
- Operational failures or malfunctions may result from technical issues, improper installation, damage, wear, or misuse.

#### Hot Air Balloon Risks:

- Collisions involving the User's hot air balloon and other balloons, objects, or structures, regardless of the Product's operational status.
- Structural impacts on the User's hot air balloon due to the Product's placement, misuse, improper installation, or lack of maintenance.
- Damage to the User's hot air balloon caused by rubbing, cutting, snagging, or fire.
- Detachment or falling of the Product, leading to injury or property damage.

#### Interference Risks:

 Potential signal interference with aviation instruments, emergency communication systems, or other wireless communications.

#### Legal Risks:

Depending on local laws, output power, or frequency selection, a license may be required to operate
the Product legally. The User is solely responsible for ensuring compliance with local laws regarding
wireless communication and aviation regulations. Refer to the provided instructions for guidance.

#### **General Risks:**

- Injuries, fatalities, or property damage directly or indirectly resulting from the Product's use or misuse.

- The Product is sold under FCC Part 97 regulations and may only be legally operated by
  individuals holding a valid amateur (ham) radio license. Operation of this device without a valid
  amateur (ham) radio license is a direct violation of FCC Part 97 regulations and may result in
  legal penalties, including fines or other enforcement actions. The User assumes full responsibility
  for obtaining the necessary licensing before operation.
- **Properly install, maintain, and operate** the Product in accordance with the Company's instructions.
- Display the required FCC callsign during operation and ensure the Product is used lawfully.

 Inspect the Product and all batteries regularly for wear, damage, or defects, and replace components as needed.

This release applies to, but is not limited to, **any injuries, fatalities, property damage, or losses** resulting from the risks outlined in the **Acknowledgment of Risks** section of this Agreement.

The Company shall not be liable for any damages, injuries, or losses caused by the User's failure to follow instructions, improper use, or legal non-compliance. The User agrees to adhere to all safety, maintenance, and operational guidelines provided by the Company.

### Retention of Waiver Notice

The waiver notice slip containing the QR code and link to the full Waiver of Liability, Assumption of Risk, and Indemnification Agreement and Instructions ("Waiver Notice Slip") is a critical component of the Product. It must remain securely attached to the Product case at all times. By purchasing the Product, the User agrees to the following:

#### 1. Original Owner Responsibility:

 As the original owner of the Product, the User accepts full responsibility for ensuring that the Waiver Notice Slip remains intact and legible during their ownership. If the Waiver Notice Slip becomes detached, damaged, or otherwise unreadable, the User must immediately contact Clear Above LLC at clearabovecamera@gmail.com to obtain a replacement.

#### 2. Transfer to Subsequent Owners:

o If the original User sells, gifts, or otherwise transfers ownership of the Product, the original User agrees to provide the Waiver Notice Slip along with the Product to the new owner. Before completing the transfer, the original User must obtain the new User's signature on this acknowledgment, confirming that they have read, understood, and agreed to all terms herein. This ensures the new owner is fully informed of and bound by all terms of this waiver.

#### 4. Notice of Legal Accountability:

- This notice is intended to comply with applicable Michigan laws regarding product liability and consumer protection. Any disputes regarding the liability or enforceability of this waiver shall be governed by Michigan law, and the original owner may retain liability until the Waiver Notice Slip is replaced or transferred.
- The original User is responsible for providing the Waiver Notice Slip to any subsequent owner.
   Clear Above LLC is not responsible for any claims, damages, or injuries arising from the use of the Product by a new User, regardless of whether the Waiver Notice Slip was provided to a new User during a transfer of ownership.

## General Applicability Across Products

This Agreement applies to all Products purchased from Clear Above LLC, including any current or future Products sold or distributed by the Company. By purchasing and using any Product from Clear Above LLC, the User agrees to be bound by the terms and conditions outlined in this Agreement.

## Waiver of Legal Claims

The User waives their right to sue or seek compensation for damages resulting from the use, misuse, or malfunction of the Product, except where prohibited by law or where gross negligence or willful misconduct by the Company is proven. The User does not waive the rights guaranteed to them by Michigan consumer protection laws.

### Indemnification

The User agrees to indemnify and hold harmless Clear Above LLC, its owners, employees, agents, and affiliates from any claims, liabilities, damages, losses, legal fees, or judgments arising from:

- Failure to follow the Product's instructions, safety guidelines, or operational requirements as provided by Clear Above LLC here: www.clearabovecamera.com/instructions.
- The User's failure to comply with laws, regulations, or licensing requirements.
- Injuries, fatalities, or property damage caused to third parties resulting from the use or misuse of the Product.
- Interference caused by the Product with other devices or systems.

This indemnification obligation shall survive the termination of this Agreement and the User's use of the Product. This indemnification does not apply to claims arising solely from the Company's **gross negligence or willful misconduct**.

## Dispute Resolution and Binding Arbitration

Any disputes arising out of or relating to this Agreement, including its formation, interpretation, or alleged breach, shall be resolved exclusively through binding arbitration administered by the American Arbitration Association (AAA) under its Consumer Arbitration Rules. Arbitration shall take place in Grand Rapids, Michigan, unless otherwise agreed by the parties.

#### **Waiver of Court and Class Action Rights**

By agreeing to arbitration, the User waives their right to a court trial and to participate in any class action, collective, or representative proceeding. All claims must be arbitrated on an individual basis.

#### **Costs and Fees**

Each party shall bear its own legal fees. Arbitration costs will be allocated in accordance with the American Arbitration Association (AAA) Consumer Arbitration Rules, unless the arbitrator determines otherwise.

#### **Small Claims Exception**

This arbitration agreement does not prevent either party from pursuing claims in small claims court for matters within its jurisdiction.

### **Errors and Omissions Disclaimer**

Clear Above LLC is not responsible for any errors, omissions, or changes in the Product or its associated instructions over time. If any concerns arise, please contact clearabovecamera@gmail.com.

### **Applicability Across Jurisdictions**

This Agreement complies with applicable laws and shall be interpreted to achieve its intended purpose within legal limits. The User acknowledges that the enforceability of liability waivers may vary by jurisdiction. If any provision is found invalid or unenforceable under local law, the remaining provisions shall remain in full force and effect.

This Agreement is **governed by the laws of the State of Michigan**, without regard to conflict of law principles. Any disputes arising from or related to this Agreement shall be **resolved exclusively through binding arbitration**, as outlined in this Agreement, **except where prohibited by applicable law**.

By using any Product from Clear Above LLC, the User **agrees to be bound** by the most recent version of this Agreement, including future updates.
