CONRAD ERNST, OSHKOSH SOLDIER, WOUNDED IN KOREA

Among Wisconsin men named in a United Press dispatch of department of defense casualty list No. 110 was Cpl. (now sergeant) Conrad R. Ernst, son of Mr. and Mrs. Conrad E. Ernst, 47 Cedar street.

He was listed as injured.

The Oshkosh soldier was a member of Company C, 91st infantry regiment of the Second division in action in Korea. A telegram received by his wife, the former Donna Schwartz, stated he was injured Aug. 20. However, according to letters received later, he appears to have been wounded at a later date in August.

The 22-year-old Oshkosh soldier joined the army Sept. 1, 1948, and was stationed on Okinawa for about 15 months. Returning to the United States on a 45-day furlough, he married Miss Schwartz July 1, this year.

In the latest letter, received Tuesday, she was informed that he is still hospitalized in Yokohama, Japan. According to his letters, he was apparently injured when a mortar he was operating backfired.
