Notification of acceptance will be sent out at the end of January.

RESPONSIBILITIES IF SELECTED:

1. Attend Local Training - see Leadership Training Contract for details.
2. Attend Maine Mini Camp (MMC) at **the end of April 2025 TBA**.
3. The program cost is **\$TBA**, not including travel fees.
4. If the applicant decides to accept, a nonrefundable deposit of **\$500 is due 2/12/25**, in order to secure the delegate's spot. The remaining balance is due 5/5/25. If the program is canceled or if you have to cancel prior to 5/5/25, all but \$200 will be refunded. If you cancel after 5/5/25, the payment will not be reimbursed unless a new delegate is found as a replacement.
5. Support all other costs of preparation such as spending money and emergency money (to be returned if not used) and other preparation costs.
6. Fill out all appropriate health and legal forms on MyCISV and submit your passport information for the travel coordinator.
7. Reflect and share your experience with the greater CISV Maine community, including presenting about your experience at the 2025 Fall Annual Meeting and Showcase (beginning of Nov. 2025).
