Abstracts are 200-250 words. Only 1 paragraph uses the Book Antique font size 11, italic, space 1. Abstract is not an introduction, or the conclusion of the discussion. Limited abstract space, must contain briefly related to (1) the main problem or research purpose; (2) method; (3) findings; and (4) conclusion. Other important things can be contained in the abstract that are significantly considered to contribute to research

INTRODUCTION

The introduction is a maximum of 500 words. Book Antique font size 11 spaced 1.3. The paper size uses A4 (any form of size including letter, F4 or whatever will not be accepted). Please explore more background words for your paper and your current research position among other research on related themes. You should discuss here also the

relationship of your research with other researchers; Literature review, especially on the most relevant new academic work, published in high-reputation journals, is a must.

In other words, try to answer at least two questions: (1) why do you believe your research question is so important to answer; and (2) how other scholars answered or did not, or how you think your answer will contribute to future research. A detailed description of your method of conducting your research doesn't need to be written in the introduction, but if you think you should, you can mention it in a few sentences or two. A little exploration of the flow of your discussion and the expected final result would be a good point to close this introductory section.

Each quote is written in a specific way that can be identified as a different "quote" from your original text (Rahmat, 2010). At the end of each quote, you must put a reference in the form of a body note in the **APA Sixth style** (Setian & Putranto, 2019; Munandar et., all, 2020). *You are required to use Mendeley, Zatero, Endnote, or similar apps.*

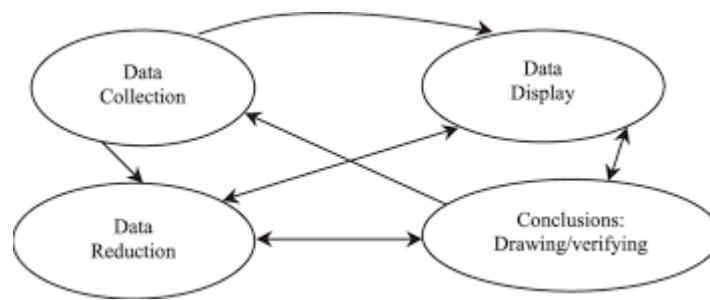
METHOD

The conclusion must answer what the purpose or question of the study is. Also interpret the results and discussion of research in a more comprehensive manner. Suggestions can also be included here, intended for practical action (the company under study), for the development of new theories, and for further research.
