- o Moving Dataverse storage to cloud storage on the OLRC
 - i. Geographically distributed
 - ii. Replicated to 3 of 5 storage nodes (Guelph, Toronto, Queen's, York, Ottawa)
 - iii. Doing testing; seeing improved download speeds
 - iv. There will be one day of downtime planning for over a weekend
 - v. Will send out email for this and a banner notice
- Globus transfer for large data
 - i. Working with Globus team to make sure files that are restricted cannot be access through Globus
- Accessibility changes being made such as colour contrast tracked in spot docs
 - i. Working with Harvard as well
- o Dataverse North

- SP in discussions with group related to support, training, and community development
- ii. Update on this at next meeting
- SP CoreTrustSeal cohort with a cohort
 - i. Content on project website https://spotdocs.scholarsportal.info/display/DAT/Dataverse+CTS+Certification+Project
 - ii. Gap analysis added working with Dataverse North Policy Working Group to work with member institutions on policies and procedures
 - iii. SP doing activities and events specific to Dataverse
 - iv. Portage/NDRIO general announcement on successful applications to their cohort coming soon
 - v. SP joining Portage cohort
- Journal Blind Review Dataverse
 - i. SP could set this up within their network developing a workflow
 - ii. Unpublished dataverse in SP root not visible to public
 - iii. Researcher could contact their local rep
 - Update your institutional documentation with information about this use case and contact information to researchers who would like to use this service
 - iv. Rep contacts SP to get researcher anonymous credentials no information about researcher is tracked
 - Could institutional rep be added to support deposit, but would want rep/ institution name to also be anonymous - SP will look into this and how this would work
 - Author/ depositor fields would not show author credentials but would be general/ anonymized (e.g. Researcher 1)
 - v. Will not be able to publish but can create a Private URL
 - vi. After review period is over, they can chose to move the dataset into the appropriate dataverse instance and publish it SP would support this
 - vii. Will set this up on demo site for admins to test
- Non- institutional dataverses in the root
 - i. Schools can set up dataverse in the root to support groups/ multi-institutional project/ sponsored group
 - ii. Email from sponsor institution is required by SP to set these up
 - iii. 100GB of storage for free, additional storage can be provided by institution
 - They would need to work the sponsor institution to get more storage if they need it
 - Sponsor to work with SP to determine increased storage
 - iv. Direct support and training will be required by the sponsor institution
 - v. Think about having an agreement with the group
 - vi. Sponsoring institution would be responsible for long-term management of the dataverse
 - vii. More information and workflow documentation will be made available
- 3. Community Topics: Journal Dataverses (Isaac Pratt, McMaster)

- Canadian Journal of Economics contacted McMaster RDM about setting up a dataverse for their data
- Currently data is uploaded as supporting information associated with a publication
- Trying to make data more FAIR
- Require data and code be submitted for review and shared when possible
- Curation activities done by Data Editor including require inclusion of a readme file
- Journal needs:
 - i. to review/ approve data submissions
 - ii. Persistent identifiers
 - iii. Metadata fields to easily link dataset to publication
 - iv. Licensing options
 - v. Training of journal staff and authors
 - vi. Need for a dataverse distinct from an institution
 - vii. 5GB of storage per year (100 GB initial allotment)
- McMaster will host the dataverse for now
- SP will host in root in (see Non-institutional dataverse discussion above)
- o Written an MOU
 - i. 3 year term
 - ii. Training for staff and author is a joint effort
 - iii. Technical support for authors is journal responsibility (McMaster and SP backup)
 - iv. Curation responsibility rests with journal
 - v. Storage costs will be passed on from SP when extra storage is needed
 - vi. Agreement

 - Can share this MOU, but please remove the references to the CJE and McMaster
 - vii. MOU/ Agreement could be transferred to another institution at end of current MOU period
- Isaac's slides will be posted on spotdocs page
- Proposed a SSHRC partnership grant to support training journal data editors on curation (e.g. data citation, Ilicensing, complications around sharing secondary/ tertiary data)
- What happens is no member institution can pick up the sponsorship of a MOU?
 - i. Further discussion needed here and included in service articulation
 - ii. Understanding of long-term preservation between the journal, sponsor institution and SP needs to be articulated in service policy
