Acceptance of the Terms of Use

These terms of use are entered into by and between you and Ponder Technologies Inc. (“**Company**,” “**we**,” or “**us**”). The following terms and conditions, together with any documents they expressly incorporate by reference (collectively, “**Terms of Use**”), govern your access to and use of ponder.ai, including any content, functionality, and services offered on or through ponder.ai (the “**Website**”), whether as a guest or a registered user.
