



# Car & Equipment Check List

## SAMPLE SCRUTINEERING FORM - NOT FOR USE

All items to be checked by the scrutineers prior to commencing track activity.

Requirements	Yes/ No
2x Brake Lights/2 x Hazard Lights operate and are clearly visible – <i>Night time driving requires 2x Headlights or LED Light Bar and Rear Parker Lights.</i>	
Approved Helmet/Goggles/Racewear suitable (100% cotton or other fire-resistant material Long Sleeves and Pants)	
Seat/s are fastened and secure to their mounting points	
Seatbelts or Harness/es are approved ( <b>minimum 4 point harness for Experienced/Advanced/L1/L2</b> ), no rips or tears/fatigue and in good condition. <i>Shoulder belts not more than 45° from belt mount to rear of seat.</i>	
Windscreen, No cracks, or damage. Vision must be clear both front and rear	
Rear vision mirror/s set and safely mounted	
Wheel Nuts are tight and secure. (Car's missing wheel nuts will not be passed)	
Bonnet secure, bonnet pins must be firmly attached to both bonnet and car	
No visible oil, fluid leaks	
No rust, cracks, holes in bodywork of vehicle, including firewall and shifter area	
No loose bodywork or trim (This includes FRP) - <i>is anything dangerous on the car?</i>	
Battery Terminals are secure; battery clamp must be tight (Terminals must be taped if exposed)	
Competition number to be visible ( <i>Passenger side windscreen under window banner - supplied</i> )	
Brakes - Pedals must have a gripping pad/surface and be firm	
Battery triangle, optional	
Power cut-off, optional	
Fuel system isolated from occupants ( <i>Fuel cells must be separated either via steel or aluminum firewall or in a steel or aluminum sealed box</i> )	
Fire Extinguisher, where fitted must be secure and in date. Must be securely mounted.	
Oil Catch Cans are required for all wet sump systems or OE system (breathing back into intake)	
Roll bar/cage must meet Racers specifications ( <i>required for L1 or Experienced/Advanced Competitors</i> ) – <i>is it full or half cage?</i>	
Steering Wheel secure (No play)	
Clearly visible and accessible tow point front and rear	
No loose items in car
