1. Introduction

Heading 2

This subsection gives guidance on the paper's layout and the names of the styles for the various elements of the text.

1.1.1 Heading 3

A4 (297 × 210 mm). Two columns, except for extra wide figures or tables. All text and axes labels should be sized to be at least 8 pt or equivalent in the final version to ensure legibility. Change to a single-column, full page width section if figures or tables will become cramped and poorly legible in a narrow column.

1.1.2 Margins and page layout

Select A4 paper size, portrait orientation. Margins set as follows: top 25 mm; bottom 30 mm; sides 20 mm; space between columns 8 mm. Do not number the pages.

2. Methods

2.1 Body text and lists

For the text paragraphs of the paper, use the **Body text style**.

Use numbered headings up to a maximum of three levels. After that, use bulleted lists or numbered lists if required. Below are examples of lists:

- Oxygen {This is **List bullet NACA style**}
- Nitrogen
- No colons or commas are required—only a full stop after the last item.

Here is a numbered list:

- i. **These items are in style**
List numbered (i) Roman A
- ii. Due to a quirk in MSWord, if you need to start a similar second or third list, use preformatted styles **List numbered (i) Roman B** or **List numbered (i) Roman C**.

2.2 Units

2.2.1 Units

Use SI units throughout your text. Leave a space (or a non-breaking space – CTRL + SHIFT and SPACE BAR) between the numerical values and the units.

If preferred, you may use the alternative notation for units "Calibration standards of 0.1 µg.L⁻¹, 0.5 µg.L⁻¹, ... were prepared from 100 mg.L⁻¹ NIST". However, use a consistent style throughout your paper.

2.2.2 Equations

Number all equations at the right edge of their column.

3. Results

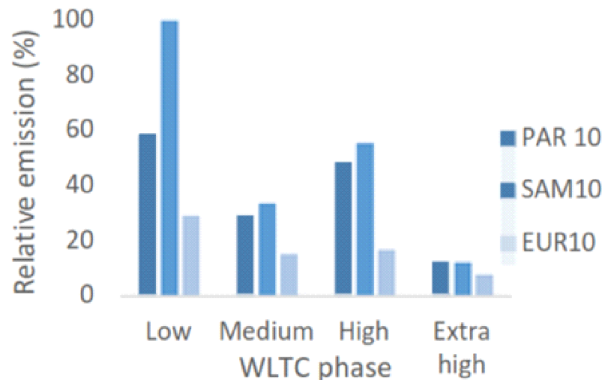
3.1 Figures and tables

Because the papers will be published as submitted, illustrations must be inserted into the text at the first convenient position after the first text mention (without splitting any paragraph).

Every figure or table must be mentioned in the text at least once.

Paste, Paste Special, JPEG or Picture (Enhanced Metafile). Using the menu options "Picture Tools, Position, Position in line with text", position the image so that it is located within a paragraph that moves with the text. Use the format

style "Figure Place Holder" to format this paragraph – this paragraph uses the command "keep with next" to ensure that the picture and its caption are not separated across column or page breaks.

3.2 Tables

Tables may span one or two columns. If necessary, a large table may be presented in landscape orientation, i.e. rotated with the top of the table on the left-hand side of the page. The primary requirement is that the table's content should be legible, i.e. a minimum 8 pt font size in the final printed version.

4. Discussion

4.1 Citations and List of References

Text citation requires only the name of the author (or authors) and the year of publication (with no comma between the two). Page numbers may be included where appropriate, as in 'Milligan (1955, pp. 245-247)'.

Text citations referring to the authors in mid-sentence appear as Khumalo and Baleka (2019, 2020a, 2020b) or Burger et al. (2017), but

should preferably appear at the end of the sentence as here (Khumalo and Baleka, 2019, 2020a, 2020b; Burger et al. 2017).

4.2 Additional heading as required

The conference proceedings are published electronically. Any claims about the performance or quality of a product or service should not use superlatives but be demonstrated by data.

5. Conclusions

5.1 Plagiarism

Direct quotations from previously published work must be identified by being enclosed in inverted commas for short passages and by indentation and italics for long passages (more than three lines).

5.2 Citation and reference checking

Before submission, cross-check that every citation has a corresponding entry in the reference list and that every item in the reference list is cited at least once in the text.

5.3 Authorship and Permission to Publish

The lead author is responsible for all material contained in the manuscript they submit and for ensuring that all co-authors must agree in written or email to the submission of the paper.
