1. Background and Introduction

5. Submitting an Application

a) In order to submit an application, you must fill in all mandatory fields and answer all questions within the application form on the Program website.

- b) Applications must comply with guidelines and recommendations set out on the Program website.
- c) Applications must be submitted in English.
- d) The submitter approves that he/she has the legal authority to submit the application on behalf of the company.

6. Timeline

After the applications have been submitted, the Program will run in accordance with the following indicative timeline. We reserve the right to change any of the timeframes indicated on our Program website (changes will be posted on the Program website):

- November 15,2024 Application opens.
- December 2, 2024 Application Deadline
- December 2-15, 2024 Screening Process
- December January 2025 Workshops with Axis: Startups that pass the screening process will participate in a workshop with Axis and event partners experts to discuss business opportunities, potential joint value propositions, tech requirements, etc.
- January Axis will announce the selected startups via email and Program on its social media platforms, the Program website and on an external media websites
- Startups will be required to confirm their participation once selected within 24 hours.

7. Public Relations

The Program will be covered by media and by applying to the Program you agree that you may be mentioned in the articles.

8. Selecting the Startups for the Program

- a) The team will make its decision for the Program based on the application forms, demos, workshops and based on the startup's go to market strategy.
- b) Decisions made by the Team are final.
- c) Whenever we need to contact you in connection with the Program, we will use the contact information provided by you in the application form. We are not responsible for incomplete or incorrect contact information provided.

9. Intellectual Property Rights, Information and Publicity

a) You confirm by applying to the Program that you lawfully own all Intellectual Property Rights ("IPRs") subsisting in your application to the Program and that your participation does not infringe on any third party's IPRs. You are responsible for obtaining any and all necessary permissions from third parties to use their IPRs in your application.
