The **May 2023 Term of the Barbour County Grand Jury** met on May 22, 2023. Presentments were made by Prosecuting Attorney Andrew Lynn Phillips and Assistant Prosecuting Attorney Kelsey Gross. The Grand Jury was presided over by the Honorable Judge Shawn D. Nines, Circuit Judge of the Nineteenth Judicial Circuit. Arraignments will be held on May 31, 2023, beginning at 9:00 o’clock a.m. in the Barbour County Courtroom.
